Aquatic/Canal - Director Plizga (Chair)

Update on plantings around Great Scott Lake (West Lake). Manager Feldkamp & I met with Earth Balance (Contractor) regarding the amount and selection of plants. The new quote should be more in line with our budgeted dollars. Approximately \$4,400.

Truxor being used to cut Green Belts. We have a tentative meeting with Dr. Mark Hostetler who teaches Wildlife Ecology and conservation at the University of Florida.

<u>Director Plizga</u> moved the Board to spend \$200 to cover expenses for Dr. Mark Hostetler, who teaches wildlife Ecology and Conservation at the University of Florida, a consultant who advises communities on things they can do to help preserve native animals, birds and plats. 2nd by Director Cowin. Motion carried unanimously.

Budget & Finance - Director Killion
