WHEREAS, the Board adopted a Resolution Increasing Transfer Assessment/Charge (the "2015 Resolution") on July 15, 2015 to increase the Transfer Assessment/Charge to One Hundred Dollars and No Cents (\$100.00), which 2015 Resolution was thereafter recorded on July 31, 2015 in Official Records Book 3997, Page 1914 of the Public Records of Charlotte County, Florida; and

WHEREAS, the Board wishes to increase the Transfer Assessment/Charge to One Hundred and Fifty Dollars and No Cents (\$150.00) per Lot/Tract.
