Hello Everyone,

June signals the start of our storm season, whether it is frequent rain and thunderstorms or the more serious hurricanes. Once again, we will be hosting Patrick Fuller, Charlotte County's Director of Emergency Management to walk us through how to be prepared for the serious storms and hurricanes. Please join us on June 15th at 2 pm at our Community Center for his presentation and to learn more about our Community Emergency Response Team (CERT), who actively assists the County in many different types of emergencies.

The storms and rain are also good reminders for us that the 30 miles of waterways through Rotonda West, plus the greenbelts and ponds in Broadmoor Park are part of a crucial major area-wide drainage system into the Gulf which helps protect our community from flooding disasters. The greenbelts are a system of water retention areas, which is why is takes time for them to absorb the water. The swales in front of homes also help carry the water into the system as well.

Please make sure that you and your home are prepared for our annual storm season. Whether it is high winds, heavy rains, thunderstorms or hurricanes, a few hours of planning and preparation now will save you countless hours of worry later on.

BOARD APPROVES COMMUNITY CENTER REOPENING GUIDELINES

The Rotonda West Association Board of Directors, at its May 27 meeting, approved in final form guidelines for reopening the Community Center for general use after the shutdown occasioned by the Covid-19 pandemic.

The following guidelines go into effect June 1, 2021:

- The Community Center will be open for its full lawful capacity of 233 persons.
- Masks and social distancing of three feet are no longer required. While the Board recommends these as good public health practices, they are personal choices and not required for use of the Community Center.
- A temperature check, the contact tracing log, and the Covid-19 release form are no longer required and will not be available.
- Hand sanitizer will continue to be provided. In addition, the facility will be sanitized daily by RWA staff.
- Rest rooms will be open. However, the kitchen will remain closed and water fountains will continue to be unavailable. No sharing of food or drinks will be permitted in the facility. These are temporary measures and will be reconsidered as circumstances dictate.

This final version of the guidelines was approved at the most recent Board meeting on May 27. There are earlier drafts which differ from this one in some particulars. Please be sure you are looking at the current and final version – this one.

With respect to Covid-19 there appears to be light at the end of the tunnel. But it isn't over yet. All of us are anxious to get back to something resembling normal. To that end, the Association urges you to continue to take appropriate precautions. Get vaccinated, if you haven't already. And if you feel sick, please stay home.

DEED RESTRICTIONS, RESIDENTIAL MODIFICATIONS AVOID "ASSAULT ON THE SENSES"

Any homeowner who has experienced the neighbor from hell (crams miscellaneous vehicles and equipment onto their lot, knows no quiet hours and never mows) appreciates the certainty and respectability of a homeowner's association's deed restrictions and residential modification guidelines.

In 2020, Rotonda West's Homeowner's Association revised both its deed restrictions and its residential modification guidelines. Copies of both were mailed to all HOA members in late December. The 30 pages of documents can be less than scintillating, but very important, reading and every member should make an effort to familiarize themselves with the documents. They may also be found on the Rotonda West web site - https://rotondawest.org/living-here/

According to floridaforboomers.com, deed restrictions play an important part in preserving a homeowner's investment:

It can sound like a pain to have to pay these fees and abide by these restrictions especially if you are coming from a community that doesn't have any fees or restrictions. But all these fees and rules, as inconvenient as they may sometimes seem, do serve the important purpose of protecting your home values. If you are going to pay a quarter of a million dollars or more for your new home here in Florida, you want to know that someone is looking out for you and your investment. Ask any reputable real estate agent or property appraiser and they will tell you that communities governed by homeowners' associations have the best track record of preserving and increasing home values.

Deed Restrictions

In short, any new or modified construction in Rotonda West is subject to approval, as are exterior walls,



fences or screening; sheds, temporary storage units and accessory buildings; structure sizes; flag poles, antennas or reception/transmission devices; types of pets (no monkeys, poultry, livestock, etc.); no unreasonable annoyances or nuisances; maintenance of dwellings, landscaping and lots; clothes drying (keep it behind the house and within a fenced area); regulation of common areas; maintenance and improvement within canal areas; anchoring of boats and watercraft; sign specifications; garage/lawn sales and auctions; vehicle operation and parking; overnight vehicle passes and additional owners' responsibilities.

The deed restrictions document also outlines association membership and assessments, charges and fees. The document declares that liens for unpaid assessments and charges include interest (at the highest rate allowed by law), late fees and costs and expenses of collection, including reasonable attorneys fees and costs. Rights of the grantor/developer are also set out.

A section outlining enforcement of deed restrictions includes fines that may be assessed each day of continuing violation. Fines are limited to \$5,000 in aggregate and fines of \$1,000 or greater not paid within 30 days become a lien on the lot/tract of the owner who owes the fine. Additional penalties may include suspension of use rights and association voting rights.

Changes

Residential Modification

Making a change on your lot/tract? Chances are the change will be subject to residential modification guidelines. From colors of dwellings, new roofs or reroofs, dwelling additions or modifications, the residential modification committee is charged with determining the appropriateness of lot/tract changes. Details of the residential modification committee guidelines are included in the late December mailing and are located online on the Rotonda West web site (https://rotondawest.org/living-here/). Often, contractors making residential modifications will submit the forms for approval on the property owner's behalf. If not, the forms are also available online at the above web address. Rotonda West Association employee Tammy Birdsong will also be able to assist with questions via email: tammy@rotondawest.org.

The Rotonda West HOA actively enforces deed restrictions and residential modifications. A recent weekly HOA manager's report wrote that during the period April 8-May 13, property owners were contacted by e-mail, phone or letter for 592 violations. Sixty-five of those violations had no residential modification approval. But despite the large number of violations, apparently just 10 were unable to achieve resolution and the foreclosure process being instituted. Liens were being released on four properties.

Rotonda historian Jack Alexander wrote in "Rotonda The Vision and the Reality," that the creation of a recreational vehicle association went a long way to alleviate parking issues within the development. He further told of a resident that continually hung her laundry out to dry in full view of golfers and neighbors. By noting that one woman's fresh-smelling laundry is another resident's irritation, Alexander illustrated that deed restrictions and the residential modification process goes a long way to relieve "assaults on the visual senses of many residents."

ATTENTION: RWA WEBSITE IS IMPROVING! CHANGES ARE ON THE WAY!

The Rotonda West Association (RWA) has ambitious new plans for improvements in our website! RWA President Patricia Aho, Manager Derrick Hedges, and Communication Specialist Joe Harris, have been researching ways to make the site more secure and more useful to our members. In a few months, you will find that when you visit the home page of our site (rotondawest.org) you will need to register to gain access to the rest of it. The home page will be the only public part of the site. To register, you will have to choose a username and a password and thereafter you will use them to sign in to see more than the home page. The plan is to change from a public website to a private "members only" one. Some advantages to members that the RWA anticipates are: having two way communication with the RWA; being able to vote "on line" as well as make payments "on line"; having access to their personal accounts; having the ability to respond to surveys as well as receive documents and announcements that formerly would have been mailed. The increased privacy will enable recorded meetings to be available only to members. Minutes to meetings will also only be available to members. There are many other advantages to having a private site and the RWA plans to take advantage of them as the it evolves. Currently, the RWA communicates with members both by mail and through the website. In the future, some of the information that was mailed will be published on the web site instead. Since one mailing can cost upwards of \$10,000, this will result in a big savings in postage alone. Other improvements are being investigated too! More information will be available later. For now, you just need to know that in the near future, you will be required to register to gain access to our website.

Deed Restrictions

I asked Holly Carr, the RWA Deed Restriction Administrator what questions she was asked most frequently and here are her answers in reverse order:



Holly Carr Deed Restriction Administrator

5. QUESTION: Can I rent my home in Rotonda West?

ANSWER: Yes, you can rent out your home. The tenants MUST follow the Deed Restrictions.

4. QUESTION: Is there a limit on how many pets are allowed in your home?

ANSWER: There is no limit on how many pets you can have.

3. QUESTION: Are we allowed to have sheds?

ANSWER: NO.

2. QUESTION: Do we have a noise ordinance?

ANSWER: We follow Charlotte County's noise ordinance. Quiet time is between 10-PM and 6- AM.

AND.....The number one most common question asked is.....drum roll..........

I want to park my recreational vehicle in the RV parking lot in the circle.

Who can I talk to?

ANSWER: The RWA doesn't own or manage the center circle RV storage facility. It is privately owned by the developer. The manager is Barbara Peszko. You can contact her at 941-697-7592.
