Volunteer Identification Process for the RWA Volunteer Recognition Banquet

Rationale: Volunteers are an integral part of the successful operation of the Rotonda West Community. The annual Volunteer Recognition Banquet, which is sponsored by the RWA (Rotonda West Association) Board, acknowledges and celebrates the accomplishments and service of its volunteers. It is important that a process be in place to insure that volunteers are properly identified for recognition.

Volunteers are identified and selected from three areas as follows:

- 1. Volunteers who serve as members on Board-approved standing committees. These volunteers are identified from the rosters approved by the RWA Board for the previous year. This is compliant with existing past practice.
- 2. Volunteers who serve on operational sub-committees of the standing Committees. These include, but are not limited to, the Christmas Decorating sub-committee the Christmas Parade sub-committee. These volunteers may be temporary in nature and are identified by the chairs of these sub-committees for service in the previous year. This is compliant with existing past practice.
- 3. Volunteers who provided a significant service to the Rotonda West community by volunteering their time, talents and/or treasures on a specific RWA project, in the previous year. These nominees are recommended by community members to members of the Community Relations Committee for consideration by the Volunteer Recognition Banquet sub-committee. The names of successful nominees will be included on the mailing list to receive an invitation. Where questions arise relating to a recommended individual's status, the resolution will be at the discretion of the Community Relations Committee chair or the president of the RWA Board. This is a new practice.

The volunteer identification process must be completed six weeks prior to the Recognition Banquet. Adopted by the Volunteer Recognition Banquet sub-committee on September 27, 2018.

• The committee also discussed the fact that we will no longer give a gift certificate to the volunteers and also, we will meet after the banquet to discuss what went well and what needs to be changed. The banquet is set for March 3, 2019.
