



TONETTES' SILENCE ONLY TEMPORARY IN TIME OF COVID

COVID-19 is hard on choral endeavors, as the Tonettes of the Rotonda West General Federation of Women's Clubs (GFWC) are (unfortunately) learning.

Back in 1999, as the Rotonda West Women's Club was planning its 25th anniversary celebration, it was determined a choir would enhance the events. As the GFWC Florida promotes music as part of its ART and Culture Community Service Program, the Tonettes fit nicely in the scheme of activities.

The Tonettes were a natural inclusion in the next Women's Club Christmas program and performances at senior citizens facilities fit squarely within the GFWC's community service directive of ART and Culture activities. Many accomplished musicians and choral directors have led the Tonettes and the group is now directed by Posey Bauer who initially joined as pianist.

Wrote Posey of the Tonettes' evolution, "As time went on, they continued to practice and decided to share their talents with residents in the Assisted Care Facilities and Nursing Homes within the community. It gave them a feeling of accomplishment to sing and have the residents tap their feet and hands to the rhythm of the music. Each season of the year found them singing the songs of season with St. Patrick's Day as a favorite and they donned their green to sing the Irish songs. The patriotic songs took precedent as they sang for the veterans at the Douglas-Jacobson Home in Port Charlotte. The songs of the Military Services would bring tears to your eyes as the elderly veterans would stand and salute when their song was sung."

But the realities of a worldwide pandemic silenced the Tonettes in March 2020, following their last performance at Brookdale Rotonda West. Their practice facility was declared off-limits and COVID's high level of contagion to seniors closed to the public the senior living facilities where they previously had sung.

As anti-COVID vaccines became available and the illness waned, director Bauer received word that the Rotonda West Community Center was again available at the Tonettes' former time on Tuesday afternoon. Believing it was safe, practices were reconvened in early June. Then the dreaded "Delta variant" led to a request by Club President Kathryn Gallagher that all groups return to mask wearing. Safety is important but masks are a hindrance to the deep breathing and voice projection required when singing.

In response, Posey cancelled recent practices. Although discouraged, the Tonettes are not ready to relinquish their songbooks yet. "I think we'll get together soon and look at our options. Everything is so uncertain now, it leaves us with a feeling of emptiness, asking where do we go from here," said Bauer. She added that the Tonettes are still hoping to salvage their annual December performance at the GFWC Rotonda West Christmas Program.







Reflecting on the past and the hope for the Tonettes' future, Bauer wrote, "For twenty-two years the Tonettes have been singing. New members have joined, older members have left through moving or passing on but the strains of music still resound every Tuesday afternoon in the Rotonda West Community Center as they continue sing the well-loved songs enjoyed by all."

Registration begins at 8:30 a.m. and the walk begins at 9:00 a.m.


Walk a little or walk a lot. We will have several routes marked. Bring your dog, bring your kids, and bring your walking shoes!

Very soon, you will need to decide what your username and password will be if you want to read the latest news in Rotonda West on the Rotonda West website. Recently, you received a letter from Patricia Aho, President of the Rotonda West Association (RWA), about the upcoming upgrade to the Rotonda West website. In it, she described that the RWA website will soon require you to register to gain access to the site. That means you will have a username and password. Deed Restrictions Protect the Value of Your Home

One of the reasons that Rotonda West is a sought-after destination for people who are moving to our area is that if you drive around it, you will see a clean, well-maintained community that demonstrates a clear pride in home and community ownership.



I enjoy driving around the different neighborhoods looking at differences in construction styles, landscaping choices, lawn orna-

ments and garden decorations. Everything looks clean and well maintained, from the palm trees in the medians to the flowers at the entrance signs to the beautifully land-scaped individual homes. It is a welcoming attractiveness that invites people to join us in living here.

Most of us work very hard to maintain our homes to the high standards of our deed restrictions and it pays off in the form of our beautiful neighborhoods. When we moved here, all of us agreed to follow our deed restrictions. Almost all of us do. Some do it because the restrictions are not hard to obey and others do it because of concern about fines for failure to follow the deed restrictions.

Our system for enforcement of deed restrictions is pretty forgiving. If you violate a deed restriction and receive a violation warning letter, you will be given a reasonable time period to rectify the problem – usually 5 days. If you do, it is a win-win situation because you don't get fined and the rules are obeyed. Also, if you want to appeal a fined violation you can do so by contacting the Compliance Committee.

Have you ever thought about exactly what deed restrictions are? Deed restrictions, often called "restrictive covenants" (especially in the context of a homeowner's association) are contained in a deed and limit how a piece of real estate can be used, and what can be built on it. Florida Statutes also govern how your property can be used. When you bought your home in Rotonda West, you agreed to abide by the deed restrictions and Florida Statutes. Deed Restrictions are actually a legal part of your deed. You should have received a copy of the restrictions at the time you purchased your home, but if you no longer have them, you can find them on the Rotonda West website at rotondawest.org. There is a link to the restrictions at the end of this article.

It is <u>not</u> the responsibility of the Rotonda West Association to provide you with a copy of your deed restrictions. It is your responsibility to get a copy at the time you purchase your home. Most Real Estate agents provide them to their clients. Some title companies provide them to their customers.

Before there was a Rotonda West Association (RWA), the developer had established deed restrictions. One of them is that when a property owner begins the construction process, he must submit plans to the New Construction Committee which is comprised of the Developer and his appointees. The Developer has the sole right to establish deed restrictions and all restrictions and proposed changes to them are approved by him. The RWA may request changes to the deed restrictions, but they have no legal ability to change them. The developer does. The RWA has a Deed Restriction Committee that continually reviews our deed restrictions.

The goal of our deed restrictions is to protect the value of our properties. You only have to drive around nearby non-deed restricted communities to see the advantage of living in a deed restricted community. Many people choose to purchase a home only in a deed restricted community to protect its value. Our Rotonda West deed restrictions cover issues like vehicle parking and the need for approval by the Residential Modification Committee for things like paint color of your home or curbing around your landscaping.

Recently, I had a talk with Holly Carr, the Deed Restrictions Administrator. She tells me that during the month of August, she handled 387 deed violations. She resolved all but 43 of them! She told me that a large majority of violations are for



vehicle parking -often parking in the swale. When she can, Holly tries to resolve violations informally by calling the owner to remedy the violation. If the owner fails to remedy the violation, a letter is sent to the violator informing them of the violation and giving them 5-7 days to correct it. If the owner continues the violation, the violation is submitted to the Board of Directors for approval of a fine.

When the fines accumulate to over \$1000, a lien will be placed on the property and the foreclosure process begins. The process of foreclosure is very slow. The whole process from the first violation to the foreclosure could take as long as 8 years. Many residents mistakenly think that the RWA is not pursuing obvious deed restriction violations, but in most cases, they really are.

Resolution of a violation can take place quickly or over the course of several years, depending on how the owner responds to the violation. Property owners have the right to appeal a violation by attending a Compliance Committee meeting and explaining why they should not be fined. The committee will consider the appeal and may waive the fine if they find it reasonable. The RWA works to maintain the value of your property.

When it comes to our Deed Restrictions, it is best to be informed.

Members have said that it is hard to know what the deed restrictions are.



All of them are on the RWA website listed below. One way to think about those that regard your home and yard is to know that ANY CHANGE YOU MAKE TO THE EXTERIOR OF YOUR HOME OR YOUR YARD MUST BE APPROVED BY THE RESIDENTIAL MODIFICATION COMMITTEE. The only exception to this rule is live plants and live landscaping. If you are in doubt, just call the Deed Restriction Administrator.

Some deed restrictions (like parking limitations regarding parking boats and trailers in a driveway) can be temporarily suspended if the property owner gets a "pass" from the RWA office. Call the office and discuss your deed restriction questions with Holly Carr, the Deed Restriction Administrator. She always tries to find a reasonable solution.
