

MSBU APPOINTS TWO NEW BOARD MEMBERS

The Charlotte County Streets and Drainage Municipal Services Benefit Unit (MSBU) has two newly appointed board members

On Tuesday, October 26, at their regularly scheduled meeting, the Charlotte County Commissioners appointed Denise Burns and Laura Ingrassia to serve as members of the board. This will be a second term for Ms. Burns and a first term for Ms. Ingrassia. Both will serve three-year terms. The terms begin on November 1 2021. The other members of the MSBU board are Chairman Nicholas Kotzalas, Vice Chair Sam Besase, and Carol Delucca. Ms. Ingrassia is replacing Curtis John who resigned.

Currently, Charlotte County has suspended all MSBU meetings because of concerns about Covid-19. If Charlotte County rescinds this policy, it is expected that there will be a regular meeting of the MSBU on December 15th, 2021. Congratulations to Ms. Burns and Ms. Ingrassia on their appointments!



The fourth Friday of every month, the Rotonda West Gardeners meet at the Community Center to learn about, discuss and trade plants. But first, they enjoy a delicious pitch -in lunch!

The best way to participate with this group is to find them on Facebook and submit a request to join. The week of the meeting, organizer Kim Duperault will post a notice of the time (11:30 a.m. to 2 p.m.), remind everyone to bring their covered dish and to "bring plants, garden items or cuttings. If you don't have any, it's OK, you will get some." Little does the uninitiated realize the potential to "get some" cuttings!

Kim said once you join, you will get a name tag. With that, you will get a 10% discount on plants at A&G Lawn and Garden Center on Placida Rd. When you arrive at the meeting you will receive a door prize ticket and be given an opportunity to buy raffle tickets at \$1 apiece. Since there are no membership dues, the raffle sales accommodate expenses for the meeting. Another bit of information: Kim Duperault and Unki Reynolds are sisters of Korean heritage. How they and their husbands ended up in Rotonda West is the community's good fortune. The sisters love plants and gardening and are a wealth of information which they enjoy sharing.

On this particular Friday in September, Unki Reynolds demonstrates just how easy succulents are to propagate. An example of a succulent plant that many may recognize is a jade plant. The characteristic of a succulent plant is thickened, fleshy parts – usually stems or leaves – that are engorged with up to 90-95 percent water for arid climates or dry soil conditions. Fun succulent fact: nearly all cacti are succulents but not all succulents are cacti.

Another great thing about succulents is that the more sun they receive, the more colorful they become. They do not need to root; a leaf or cutting inserted into potting soil will allow it to grow. Just be sure to prepare your pot so that it's going to drain well. Unki said at least two inches of rock or sand at the bottom of a pot, covered with regular potting soil, will provide sufficient drainage.



Holding up a small, colorful teapot, Unki demonstrated how a plant lover could insert various succulent cuttings that would result in a lovely arrangement. Two years age, Unki said she started her love affair with succelents and now she has over 500 plants. "These are my babies; they are so much fun!" she exclaimed. She also offered to tour her garden after the meeting.

Kim Duperault brought Malaba Chestnut plants, showed pictures of flowers to edible fruits, & passed around samples of the chestnuts to taste. Kim told the group, "Who would've guessed, it's also called Money Tree, because the germination rate from the nuts is more than 99%, thus, easy to grow

and sell. It quickly became a symbol of prosperity to grow them."

Afterward, members may ask any questions they have about any plant or dispense plant information they may care to disclose. Then, the use of the tickets becomes apparent. If one is blinded by the delicious display of luncheon dishes, that's understandable, but a long table next to the gardeners is also filled with the green of various cuttings brought in by the members. Everyone watches the numbers on their tickets as a drawing allows each to go to the table and select a cutting of their choice. Whether one's number is called quickly is of no consequence because there are plenty of wonderful cuttings to select from: fire spike, devil's backbone (also known as a zig zag plant), coral bush, vanilla orchid, oyster plant, crinum lily, ground orchid, air plant, cardboard box palm, money tree or Everglades tomato.

These gardening enthusiasts also disclose why they are so generous with their cuttings. How can you acquire new plants if your lanai/building lot is filled with your existing plants? "You only have so much room!" noted Unki Reynolds.Kim added, "Yet there are so many tropical plants which we never grow up north, and now you have a chance to grow them here. We gardeners have a hard time resisting them. When you give care, they grow well, it'll make you smile and remember the time you got them. We are spreading happiness through plants sharing!"

BOARD CANDIDATES PROPOUND VIEWS,

DEFEND ACTIONS

Residents had a chance to question four candidates for Rotonda West's two open board of director seats during Candidates' Night, September 30th at the Community Center. The candidates include a present board member, a former board member and two newer Rotonda residents.

The election will take place at the Rotonda West Association Annual Meeting, December 2nd. All property owners should have received ballots in the mail that must be returned by 5 p.m. on December 1, or they may vote in person at the Community Center on December 2 from 5 to 6:30 p.m.

Questions were solicited from property owners by the Association, and board president Patricia Aho served as moderator. The candidates spent nearly two hours explaining their views and sometimes defending their actions. They are: present board member Sam Besase, resident Cynthia (Cindy) Chatham, resident John (Jack) Metz, and former board member Andy Van Scyoc.

Wildlife Concerns

Wildlife was a subject of at least two questions put to candidates: how to educate owners about alligators in the canals, and should RWA spend funds for signage to protect wildlife?

All proposed education is a way to support the community's alligators. **Sam Besase** cited the new owner packet as a way to educate new owners about Florida's wildlife. He said the wildlife committee provides valuable training and education. **Cindy Chatham** said she joined the wildlife committee because alligators are special to her and education is key to their protection. **Jack Metz** told how he had come upon a female alligator and her eight babies sunning themselves on the canal and that residents need to learn to live with their existence. **Andy Van Scyoc** said he helped to found the wildlife committee because he believes the existence and preservation of wildlife enhances Rotonda West property values.

As for the expenditure of RWA funds to protect wildlife, particularly gopher tortoises, there was disagreement. **Besase** said the goal of the RWA is to maintain property values and purchase of gopher tortoise signs does not fall into that role. The other three believed signs can help protect gopher tortoises. **Van Scyoc** said he would even raise funds for the signs if the RWA did not pay. **Chatham** said the signs are a benefit to prospective purchasers to let them know of the existence of burrows that they may need to pay to relocate and that RWA mowing crews can avoid damage to tractors or burrows if they are made aware via the signs. **Metz** said there is probably a way that the association, the board and the wildlife committee can work together to protect gopher tortoises.

Golf Course Perimeters

Some residents' objections to the appearance of the perimeter of golf courses within Rotonda and whether a property control agreement was possible was the subject of another question. The answer was complicated.

Besase and **Van Scyoc** both said residents should be careful what they wish for because failure of a golf course in Rotonda West could result in sale of the property and undesirable development. Besase and Van Scyoc also agreed that the Rotonda West developer has exempted the golf courses of the same deed restrictions by which residential property owners must abide. Both **Chatham** and **Metz** advocated for a cooperative solution that might result in better mowing or maintenance schedules in the golf course perimeter. All agreed a negotiated solution should be possible since the golf course manager David Kelly is also on the board of directors.

RWA Challenges

What are the most important challenges facing future RWA boards?

Cindy Chatham said Rotonda West is changing. "When I came here, I was told...that everyone was over 75 years old. That's definitely not true. We have a diverse community." She added that committees should be expanded to "add voices". Jack Metz said the greatest challenge is transparency of information from the board, flowing to the association, as well as financial strength. "When I moved here and read that the assessment was only \$190 a year, I said, 'wow, that's the success of the board," he said.

Andy Van Scyoc said younger parents are moving into Rotonda. "This place needs to be a great place to grow up...it's not a retirement community anymore," he said. "When I moved here in 2007... there were no children. Now there are children on three sides of me. It's cool." Sam Besase said the challenge is to work together. He said he is for evening meetings but they don't have good attendance. He said Zoom meetings increase communications and transparency.

MSBU: Bridges and Paving

The candidates were asked how the community should monitor and report on upcoming MSBU (Municipal Service Benefit Units) projects, such as paving and rebuilding of bridges.

Chatham said she has lived in Rotonda one year and she doesn't know that much about the MSBU but she understands the need for it. Although she doesn't foresee problems or extra costs, she said the board should make sure the community receives updates, even if there is no progress. Metz said he moved to Rotonda in May, has read about the MSBU and he supports its existence although the board should be involved at the county level. Van Scyoc said the Rotonda West board has a duty to monitor the MSBU and report back to the community. "We never had a project of this magnitude... we would want to stay on top of it," he said. Besase said he has spent four years on the MSBU board and his complaint is that it only meets quarterly. Repaving the roads is going to be an even bigger project than the bridges, he said. Advocating for MSBU monthly meetings, he added, "Today was supposed to be an MSBU meeting...because of Covid it was cancelled. Now it won't meet again...until December."

Candidate Controversy

Candidates did not escape questions about their past actions.

Referring to his past board service and his resignation before the end of his term, **Andy Van Scyoc** was asked to guarantee he would actively participate and complete his term if elected. Van Scyoc said his resignation was because of a "difficult situation" – the previous association manager was a rental tenant. "I won't get stuck in that trap again," he said, and added it is his intention to serve his full term.

Chatham was asked two specific questions: whether she would vote in opposition to another board member she has criticized and whether she thought it was acceptable for a resident to sue the association. As to potential board member conflicts, she said, "we all have different perspectives. I am a great debater...but...we can find a happy medium. My goal is to keep this community going in a positive direction." About potential lawsuits against the HOA, she said she had consulted an attorney when she believed she had been the victim of non-disclosure, having to do with the enjoyment of her view of the lake upon which her home is situated. "If we (the association) make a change that is going to affect somebody's property, we need to make sure that it is disclosed." she said.

Referring to **Metz's** resume that includes management of three HOA communities in Pennsylvania, he was asked whether short term rentals should be limited to one week or more in Rotonda West. He said each of those associations had rules about short-and long-term rentals. "If someone buys a house and wants to use it as a rental, they should be able to use it", he said. **Besase** added that the Rotonda HOA visited the issue as a board and the developer vetoed limitation of rentals.

Van Scyoc was called to task because he is an administrator for a Rotonda West Facebook group that has used "derogatory language". "I don't like it. I stop a lot of threads," he said. "I usually shut them down. There is an owner's page which is the only page that we allow any discussion of the association, but, I can't watch it 24/7", he added.

Social Media

All were asked about the responsibilities of social media by board members.

Chatham said she believed social media was the reason the wildlife committee's bat presentation was well attended although she conceded board members may have a responsibility to keep negative discussions of RWA business off of Facebook. She suggested the association consider a Facebook page that would dispense information but not allow open discussion. Besase said he "tends to stay off Facebook and not get engaged in back and forth." He said many Facebook users should say "in my opinion" instead of espousing information as fact. "We're not going to run the Association by what Facebook says we should do." Van Scyoc said he believes "a lot more good comes out (from Facebook) than bad. Metz said social media can be a valuable tool to provide information to the community. "Unfortunately, there's a lot of negativity, but it can be used in a positive way," he said.

Holiday Decorations

Another question asked the candidates how they would avoid in the future the "debacle" of Memorial Day 2021 that involved holiday decorations and deed restrictions.

Metz said he was not in Rotonda at the time but he heard about it and that deed restrictions should be able to carve out exceptions in respect to the military, fire or EMS. **Van Scyoc** said an easy solution would be for sign regulations to exempt holidays in general. **Besase** said "The staff could have done differently. The board could have done differently. We all learned from it...I don't want to see it happen again." **Chatham** said she has a strong position on deed restrictions and Memorial Day. "You get three to four people deciding for 16,000," she said. She suggested compliance staff be instructed that holiday displays are not a part of deed restrictions.

Ability to Serve

The candidates were asked what factors in their lives would limit their ability to serve.

Chatham said she has children and grandchildren but with the availability of Zoom meetings, she believes there is a way to schedule her participation. "I would only do it if I was 100% sure," she said. Metz said he is retired and available "pretty much all the time...I don't see any restriction that would limit my ability to serve." Van Scyoc said in the six and a half years of his previous election on the board of directors, he only missed one meeting and that was when he was in the hospital with cancer. Besase said, "I've attended 700 meetings in the last seven years... I only missed one meeting."



ROTONDA WEST ASSOCIATION DIRECTOR JERRY ELDRED RECEIVES RECOGNITION FOR ACCOMPLISHMENTS AS OHIO PARK DISTRICT EXECUTIVE DIRECTOR

On November 9th, Jerry Eldred and some of his family members traveled to Troy, Ohio at the invitation of the Miami County Ohio Park District (MCPD). There, he was presented with a replica of a plaque that will be displayed in the main classroom of the Heritage Center of the Lost Creek Reserve Park.

The plaque is the culmination of Jerry's 20 years as Miami County Park District Executive Director. When Jerry was a student at Texas A&M, he took classes that inspired his plan to become a Park Director and fifteen years later, he accomplished that goal. Under Jerry's leadership, the MCPD has expanded from a 600 acre, 3 facility district to a 2,200 acre 15 facility one. Jerry's primary goal was education. His secondary goal was to expand the Park District. His own love of nature formed his goal of creating a hands-on environmental education program for students. He says his proudest accomplishment is that today, that program is taught in every school system in Miami County, Ohio, reaching approximately 3,500 students. He talks about how during his tenure, voters supported his vision by supporting the tax increases needed to fund both education and expansion. He says that some of the voters today are students who learned about nature through the Park District's programs. Currently, the District is building its first Education Center called Heritage Hall, so education is still growing in the Miami County Park District.

The plaque that Jerry received quotes him as saying:

Nature is life...Our future depends on each generation's respect for nature. Hands-on environmental education is the key to conservation, preservation and building love, respect and stewardship for our natural areas. 'Dirt made my lunch. Prove me wrong.' The term, Dirt made my lunch, was used in classrooms to demonstrate the fundamentals of nature and our reliance on it for our basic needs.

Jerry stresses that his talented staff were instrumental in achieving his goals and together with his own efforts, they accomplished the goals of education and expansion. As a result, there are adults today who long ago learned 'Dirt made my lunch'.

The GFWC Jennie Award is the only national honor bestowed by GFWC that recognizes individual members for personal excellence. The award is an occasion to highlight extra-ordinary women who epitomize the spirit of independence, courage and persistence through their roles as volunteers within clubs, representatives of their community and as members of their families. Charlotte Arcadia is currently Parliamentary Advisor, having previously served as Club 2nd Vice President, 1st Vice President, President and District 12 Director of GFWC Clubs including Arcadia, LaBelle, Naples, Port Charlotte, Punta Gorda and Rotonda West Woman's Club. A well-known and loved GFWC Florida member throughout the state, Charlotte's body of work was recognized on October 23rd by GFWC FL State President Dianne Foerster at left and

What is GFWC? It's the General Federation of Women's Clubs, founded in 1890 and now in its second century of living the volunteer spirit of community service. GFWC has 80,000 members within Clubs in all 50 states, the District of Columbia and 15 countries. Florida ranks second in the number of GFWC Clubs (187) and members after California. So, where does the GFWC Rotonda West Woman's Club fit in all of this? Organized in 1973 and Federated in 1974, currently at 150 members, 70% of whom live within the community of Rotonda West, the Club has work hard in Rotonda West and surrounding communities and ranks high in "second largest" Florida, not by number of members, but by accomplishments dedicated to the community, the founding principle of GFWC 131 years ago.

The 2021 GFWC International Convention was held in Atlanta in late August to award GFWC outreach programs provided throughout all states and countries. GFWC Florida placed 1st in Education & Libraries – Rotonda West placed 2nd in the state. Florida placed 1st in Environment - Rotonda placed third in the state. Florida placed 1st for Health & Wellness – Rotonda placed 2nd in the state. 

EXPLANATION OF ROLLOVER OPTION WHICH APPEARS ON THE BALLOT

(Reposted from a previous West Ways FAQ's article)

PLEASE EXPLAIN "ROLLOVER OF EXCESS RWA HOA FUNDS" WHICH APPEARS ON THE BALLOT EACH YEAR

Property owners are asked each year as a part of the RWA election process to VOTE either YES or NO to rollover excess funds. Here is Geoffrey Lorah's (RWA's outside independent CPA auditor) explanation:

- 1. Common interest realty associations (primarily condominium and property owner / homeowner associations) are organized as not-for-profit corporations. For operating purposes, it is assumed the annual budgets for these associations will be prepared on a break-even basis, meaning expenditures will equal revenues. When an association has excess member revenue in any given year, there are three basic options available to the association regarding the treatment of the excess revenue:
 - A. Refund the excess revenue on a pro rata basis to the members of the association
 - B. Obtain member approval to "rollover" the excess revenue to the subsequent fiscal year
 - C. Retain the excess revenue and report this revenue as taxable income on the association's Federal and/or State tax return
- If the members do not approve the rollover of the excess revenue, an association has two options regarding the treatment of the excess revenue; either refund it to the members or report it as taxable income.

Please note: This is a general explanation. The rollover process is primarily based on the requirements of IRS Revenue Ruling 70-604
