Administration

- The 3rd notice of Annual Assessments were mailed out 4-18 and members should have received or should be receiving their Assessments. If you have not received your annual assessment, please email us at info@rotondawest.org
- Processed and posted approximately 94% of Annual Assessment payments to member's accounts
- Collected and processed approximately 24 estoppels so far this month
- Released 1 lien on a property in the Oakland Hills section
- Recorded 2 liens on properties that have outstanding Deed Violations in the Oakland Hills section
- The Residential Modification Committee has been working hard processing and approving **107** applications, so far this month
- April 14th thru May 11th contacted property owners by e-mail, phone, or letters for the approximate 403 Deed Restriction violations. In total 44 of the violations had no Residential Modification Approval
- Continuing collection efforts by calling members with past-due account balances, collecting **19** past due payments this week

 - Mowed, trimmed, and treated the weeds along all of the Memorial Parks
 - Mowed, trimmed, and treated the weeds along all of the apex bridges in the Oakland Hills, Pebble Beach, Broadmoor, and White Marsh sections
 - Mowed, trimmed, and treated the weeds around Rotonda West, North, and East Blvd. intersections
 - Finished mowing the vacant lots in the Broadmoor section
 - Mowing vacant lots in the Long Meadow section
- Will continue mowing vacant lots in the Long Meadow section next week
- Will continue completing weekly trash cleanups throughout all sections of Rotonda West

- Cross Creek Environmental completed an additional follow-up appointment this week (5-11) treating the aquatic and terrestrial plantings around the L04 pond
- Bob Reynolds has completed the 1st canal bank mowing cycle this week in the Pine Valley section and will begin his 2nd cycle in the Oakland Hills section in approximately 4 weeks
- FloridAquatics continues treating and maintaining the aquatic vegetation growth in our canal system
- The following canals and areas have been sprayed for invasives and grasses
 - Oakland Hills(shoreline grasses)
 - Oakland Hills(trash cleanup)
 - Pebble Beach(shoreline grasses)
 - Broadmoor Park(spot treat invasives)
- FloridAquatics will be treating grasses in the White Marsh sections next week
 - Work locations are available for viewing in the Rotonda West Association Office
