Meeting was called to order by Jack Metz at 9:31am

- 1. **ROLL CALL:** Zoom connection was operational for any interested public attendees, attendees noted above.
- 2. **Approval of old minutes**: Motion to approve August 8, 2022 minutes made by Gwen Grace & second by Sam Besase. Minutes were approved as written.
- 3. Owner Input None
- 4. Centennial Bank HOA Presentation:
 - a. Liz Carpet Centennial Bank Representative provided background on serves available to reduce intensive RWA staff labor, ongoing education for staff, Board and Committee Members through association with CAI membership and integration with Caliber Software for accounting purposes. All serves reviewed indicated positive benefits for RWA owners and staff. Only downside is initial set up between staff and bank. Cost is \$2.00/property which can be reduced to \$1.00/property if owner enrolled in automatic bank transfer for annual payments. Craig Finck provided concurrence and benefits of CAI membership educational opportunities.
 - Manager Hedges noted our current bank does not offer any similar services. Further is will save a tremendous amount on postage, staff labor and offers better tracking.
 - b. Motion to recommend a transfer of Operating Account from Englewood Bank to Centennial Bank HOA Financial Management to the Board with consideration of Reserve and CDARS with comparison of Interest Rates over time was made by RoseAnne Woodliff and seconded by Gwen Grace. Motion unanimously approved.

5. **REGULAR BUSINESS**

- a. **Treasurer Report** S. Besase presented August 2022 Treasurer's Report. See attached report.
- b. Income Analysis Income from Annual Assessments has exceeded Budget by ~\$16.8K. This overage is related to collection of arrears obtained through lien process and/or excess tax sell collections. Current 2022 collections are at 96%. Fee income does not reflect bad debt write off. S. Besase asked Manager Hedges to have auditor determine the historical approximate percentage of bad debt.
- c. **Reserve Analysis** S. Besase noted RWA transfer of a total of \$600K from operations into reserve funding has occurred. A review of additional transfer of money will be evaluated after third quarter numbers reviewed.

- d. **Delinquent Property Status Update** –Manager Hedges noted continued progress on arrears retrieval. Approximately 3.59% of properties are delinquent more than 90 days. Liens are in process on 50 properties. Next arears review will happen in January 2023.
- e. **CDARS Spreadsheet Analysis** CDs continue to rollover at monthly intervals. Treasurer Besase stated Englewood Bank anticipates next CDs will have interest rate of 2.71%.

6. OLD BUSINESS

- a. Lien & Foreclosure Status Status update noted above
- **b. 2021 Audit Status** –Completed Audit is available in RWA office for any interested owners. No changes were made from draft to final copy.
- c. Audit Committee versus Random Cash Mid-Year Audit by Professional Auditor Auditor is scheduled to come in to review policies for handling of cash with RWA staff post audit. Manager Hedges noted Auditor cost would be based on labor time but scope has yet to be determined. S. Besase recommended a conference call be done with R. Woodliff and any other interested Committee Members to discuss their recommendation and Committee desires. Manager Hedges to follow up.
- d. Budget 2023 Process
 - i. 2022 Reserve Study Deep Dive –No further discussion at this time.
 - *ii.* **Building and Grounds Three Year Capital Plan -** Board did not take any action on incorporating projected expenses into Reserve Study.

7. New Business:

- a. **2023 Budget Estimates:** Spreadsheets shall be sent via email. No changes were made from our last Committee Workshop. Suggestion was made to include interest revenue update.
- b. **Board & B&F Joint Workshop Date:** Thursday, September 22, 2022 from 10:00am 12:00pm.

The RWA Manager can provide the list of DELINQUENT PROPERTY OWNERS (about 289), by address and amount owed, to the RWA BOD and RWA B&F committee members upon request. (3.59% of RWA properties.) (3rd notices sent and SUSPENSION letters sent.)

The DETAILED information on pages 2 thru 5 are provided by the RWA Treasurer to assist the RWA BOD & RWA B&F as we draw nearer to finalizing the 2023 budget over the course of the next 2 weeks.

Some INCOME line items are on an ACCRUAL ACCOUNTING basis per the Independent Outside Auditor.

Questions are solicited by the RWA Treasurer, please, from both groups *in advance* of the combined 2023 budget workshop, the 3rd week in September, 2022. (SEPTEMBER 22, 10AM-NOON)

The RWA received the annual TRIM notices (25) from the Charlotte County Property Appraiser in late August of 2022.
