Rotonda West Maintenance Staff

- The Maintenance Staff has completed the following tasks:
 - Continuing to work in **Broadmoor Park**, removing and hauling away fallen pine trees and other debris
 - Broke-down and set up tables and chairs for 1 Board Meeting, 3 Committee Meetings, 14 club and activity meetings
 - Hauled away **25** cubic yards of miscellaneous debris along the roads, right of ways, and our common areas
 - Mowed, trimmed, and treated the weeds along all of the Humpback Bridges along Rotonda Circle
 - Removed **1** large fallen tree in the Pinehurst canal section along Fairway Road
 - Adding mulch and additional plants as needed around the Community Center
 - Began working in the Pebble Beach greenbelt, clearing 3 large pepper trees, and will continue cleaning up

fallen debris in the Oakland Hills and Pebble Beach greenbelts in approximately **2** weeks

- Will begin mowing vacant lots in the **Oakland Hills** section in approximately **3** weeks
