RWA Board of Directors Fills Three Seats

During the month of December, three seats have been filled on the Rotonda West Association's Board of Directors. Two seats, Les Goodman and Jack Metz, from the election held on December 6th. The seventh seat was decided at the December 20th BOD meeting in which the vacant developer seat was filled by Karen Harvey. The developer seat is filled by a nomination by a Board member, followed by a vote by the Board members. The term is for a one year. Annual Meeting on December 6th, with Les Goodman receiving 1,038 votes, followed by Jack Metz with 911 votes. Board member Jerry Eldred received 769 votes, and Vance Absher got 588 votes.

Also decided at the Annual Meeting, the administratively essential rollover of funds was approved by a vote of 1,632 to 50. The rollover allows the Board to utilize unspent funds from the previous year to begin the next year's budget.

Just under 1,800 people voted in the 2022 Rotonda West elections, compared to the normal numbers of 2,000-2,500. It was thought that a late mailing, brought about by Hurricane Ian, was to blame for the reduced result.

If Goodman and Metz have any influence with the board in 2023, Rotonda West is in for a thorough examination of its Deed Restrictions. Goodman has been chair of the Deed Restrictions Committee, member of the ResMod Committee and former member of the compliance committee.

“Deed restrictions and residential modification guidelines are the two prime regulations everyone in Rotonda West has to follow,” said Goodman. “The initial governing documents were created in 1969 and they’re 53 years old.” Citing the changes in materials, building codes and property uses over those years, he said, “we’ve just bolted on new regulations without looking back on what we’ve done before.” He offered as an example, multiple entries referring to trash cans. “One of them says they must be in the garage and they must be behind a fence. Another says they can be behind the shrub. Another says as long as they’re not readily visible. So, which one should we follow?” Goodman concluded deed restrictions are in dire need of a “comprehensive review”. He stated at the next board meeting he will offer a motion to create an ad hoc committee to review and revise the documents. I’m 95% sure we can get this done.” Jack Metz also supports any updating of the deed restrictions. “We need an ad hoc committee of the board of directors, office staff and the community—absolutely,” he said.

Although Metz has been a resident of Rotonda West just 1 1/2 years, he has a long history of involvement as a volunteer and a professional in HOA’S. He served 16 years on the board of his HOA in the state of Pennsylvania and was a professional HOA administrator for three other communities in that state. Metz’s first run for the RWA board was unsuccessful, but he gained valuable knowledge about the community when he joined the budget and finance committee. He understands the need for a professionally run, financially strong Rotonda West.

Metz also sees a need for greater communication between the board and the Rotonda community. While some 3,000 residents presently subscribe to the Constant Contact service, gained by signing up through the Rotonda West web site, those numbers are still a long way from reaching every resident. Metz is ready to look for ways to expand that information pipeline.

The Board met December 8th for its post annual election organizational meeting and election of officers. The Board selected: Andy VanScyoc, President; Les Goodman, Vice President; Sam Besase, Treasurer; Patti Cowin, Secretary.

On December 20th, Karen Harvey joined the board. Karen states, “I am truly blessed to be part of this Rotonda West Community. I was thrilled to be nominated by the other Board members. We have a lot of work ahead of us now that the developer is leaving the property. The Deed Restrictions need updating, also. You can count on me to work hard for everyone in our community.

## ATTENTION ROTONDA RESIDENTS

There may be some confusion regarding the emergency motion passed by the  
Board of Directors on October 3, 2022, which waived the requirement for a Resi-  
dential Modification application (RMA) until April 3, 2023.

To clarify, that waiver applies to any repairs needed due to damage caused by  
Hurricane Ian.

Below are explanations for repairs that do not need a RMA permit:

- Any repairs that are "like for like". Examples: repairing your roof with the  
same material (shingles for shingles, metal for metal).
- Any replacements must be emplaced in same footprint.
- Repainting your house (where Ian scoured paint off) must be with same  
color.
- Replacement of cage must be in same color (white for white, bronze for  
bronze)
- Current Deed Restrictions and Residential Modification Guidelines must still  
be followed. (Example: wooden fences, sheds are not allowed).

## ROTONDA'S GAZEBO LIGHTING AND BOAT PARADE REFLECTS A COMMUNITY'S STRENGTH

On Saturday, December 3rd, sixty-six days after Hurricane Ian devastated this community, the people of Rotonda West showed their grit and put on a spectacular event to welcome in the holidays. The annual Gazebo Lighting and Boat Parade was in jeopardy of being canceled as the holiday parade had been, due to the destruction to homes and property caused by Ian. But Rotonda West Association President Andy VanScyoc stated that it was important for the community to go ahead with the event in whatever form it had to take, and the community responded.

Fittingly, December 3rd had been designated as "Rotonda West, 50 Years of Staying Strong Day" by the Charlotte County Board of Commissioners just two weeks prior, and that designation was clearly evident. Community Outreach Committee co-chair Karen Harvey spearheaded the organization of the event. Other groups that participated were the Rotonda Cruisers; local fire departments; the Rotonda West Woman's Club; the Blacken Blues BBQ; local band The Elderly Brothers; and Santa Claus himself; all working to make this event better than expected.

The Rotonda West Yacht Club, a vital part of the night, were one of the groups affected by the hurricane. Andy VanScyoc, also a local boat skipper and charter member of the Rotonda Yacht Club, explained the obstacles that these captains had to overcome.

My thanks go out to the Skippers who, many had to take time away from working on their damaged homes to prepare boats and help us achieve the magic number of 10. Hank Barstow's house got flooded and his boat was flipped over with one of its pontoons ripped off and deposited in a neighbor's pool, yet he made it to the show with the boat looking great. Pat Bradey's home was severely damaged and buried in rubble yet she decorated at the last minute and made the show in her battered vessel. Bryan Cox suffered major home damage and his boat was placed ashore about 20 houses down. Steve Reed's home also sustained major damage and his boat was dumped in his backyard. Kevin Walsh's boat was on the Riverhouse pool deck. Ron Wilson's boat was sitting on the dock at the marina, he's in Missouri but he offered it up for use in the parade, Pattie Cowin made it beautiful and piloted in the show. I was lucky because my house got minor damage and the boat in the backyard was refloated before the flooding receded. The Long Meadow contingent of Jeff Nicholas and Dennis White brought their boats, and Doc Coombs stepped in when my second driver cancelled the day of the event.

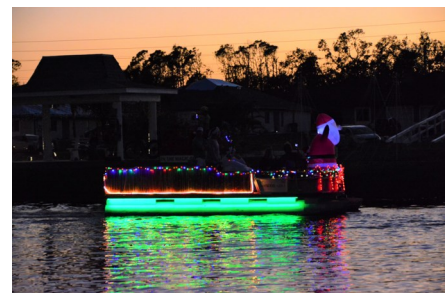

# THERE IS NO BETTER NEIGHBORHOOD IN ROTONDA WEST THAN OAKLAND HILLS

Oakland Hills resident Gini Moore wants everyone to know a few things:

- She lives in the best neighborhood in Rotonda West.
- Rotonda is pronounced RotOnda (said with a short O), NOT RotUnda (with a short U).
- Longtime Oakland Hills residents consider themselves pioneers – without Oakland Hills there would be no Rotonda West.

And Gini should know these things because her recollections of Rotonda West date back to the beginning, when her brother Starr Shaw and his wife Ann, together with their friends Ed and Pauline Hennessey, were golfing on the east coast of Florida back in 1974. They ran into a guy who offered them a free airplane ride to the west coast of Florida, to a place called Rotonda West.

The home of Gini Moore at 40 Oakland Hills Court was battered by Hurricane Ian but still stands as a testimony to what the long-time resident considers the best neighborhood in Rotonda West.

Attracted by the promise of seven golf courses named for the days of the week, both couples purchased lots and built homes in 1974. Starr and Ann's new home happened to be at 46 Oakland Hills Court. The Hennesseys, being great golfers, built on Annapolis. (According to "Rotonda the Vision and the Reality", Ed Hennessey became president of the then-Rotonda Property Owners Association in 1986.) Gini and Starr's mother moved down from Romulus, N.Y., in 1977, buying next to Starr, at 44 Oakland Hills Court.

Finally, in 1978, Gini and her husband Tom decided to buy in Rotonda and built the home she still lives in at 40 Oakland Hills Court. They moved here full time in 1981. Although Tom was a purchasing agent for a large electrical contractor in Ithaca, N.Y. and Gini, a graphic designer for a magazine, they decided to follow their dreams.

"Tom started a lawn service and he really enjoyed it down here," Gini said and added with a grin, "I probably shouldn't say this, but I was introduced to the post master (Joan Karr – she and her husband Harry built the first house in Rotonda) in the bar of the American Legion and she hired me to work at the post office on the spot. I delivered mail to all of Cape Haze and all of Rotonda, except for Caddy, Annapolis and Oakland Hills Court."



“At the time there was just five houses in Pebble Beach. It all changed while I was working there. It was just unreal. I had really, really, nice people. I delivered to 700-some people and just a couple of curmudgeons. That’s a good percentage.”

So, with members of the Shaw family at 40, 44 and 46 Oakland Hills Court, what about the odd person out at house 42? Luckily, the lady at 42 on “Shaw Row” fit in just fine. Gini reported: “Her name was Marge Artega. She was from the Bahamas and she came for golfing season. She was a lovely lady.” Gini added wistfully, “Then she had a stroke and her daughter made her sell and move back. Now I’m the only one left.”

But before the sad events that led to “Shaw Row” dwindling to one person, Marge Artega sold to another lovely lady, Kate Chinn, who had been brought up on Boca Grande, had moved north for a career, seen the error of her ways, and returned to Florida to purchase the residence at 42 Oakland Hills Court.

Hurricane Ian was just the latest, albeit the worst, in a series of storms endured by Gini and her family. She recalled the “No Name Storm” of March 1993 as a mild hurricane. She and Tom did not evacuate and lost their roof to Charley (August 2004). Their son – also Tom, but not Tom Junior because he has a different middle name - moved to Rotonda West in 2005, building in Pebble Beach, and that is where she endured Hurricane Ian.

She said, “My son wouldn’t let me come to my house to live for 10 days after the storm. I had six inches of water. We had tiled years ago, except for the carpet in the bedrooms. There were inches of mud throughout the house. A company in Port Charlotte cleaned the floors and cleared the bedrooms of the carpet. My granddaughter arranged for the furniture to be taken away.”

But Gini considers herself fortunate. She points to a camper in the driveway across the street. The camper belongs to Bob Thomson, chef at The Hills Restaurant here in Rotonda. “He lost about everything,” Gini says sadly. Chef Bob, as Gini calls him, and his wife Nicole are just about the best neighbors ever. Since Tom Moore died of pneumonia in 2020 after 72 ½ years of marriage, the Thomsons and other neighbors keep a sharp lookout for Gini’s wellbeing and safety.

Another set of neighbors that takes perhaps the best care of Gini are Steve Froggatt and his wife Gayle Peterson. Every morning Gayle comes over to empty Gini’s dehumidifier. On Mondays, Steve brings lunch. “He usually brings a grilled cheese sandwich,” she said, smiling. “Sometimes he tries to branch out to other things but I tell him to stick with the grilled cheese. His grilled cheese is really very good.”

Although the residents of Oakland Hills Court, at Thanksgiving time, were still burdened by the shock of Hurricane Ian and the mounds of vegetation, housing and structural debris in front of nearly every house that lined Oakland Hills Court (and nearly every other street in Rotonda West) they may have been scrutinizing the unfamiliar car in Gini’s driveway that very minute, as a matter of fact. The closeness and neighborliness of the residents on Gini’s street is likely the reason, in her opinion, there is no better place to live in Rotonda West, than Oakland Hills.

## **Boat America, An In-Person Boating Safety Course**

DATELINE – The Coast Guard Auxiliary, Flotilla 99, Cape Haze is offering a Boat America, in-person and simulcast virtual boating safety course, on Saturday, January 14, 2023.

The 8-hour class will be held at the South Gulf Cove HOA pavilion, 14859 Ingraham Blvd., Port Charlotte, starting at 8:30 am and finishing at approximately 5 pm. The in-person class size is limited.

The course is taught by members who patrol and are very familiar with south Charlotte Harbor, Gasparilla Sound, Pine Island Sound, South Gulf Cove and Boca Grande areas.

Successful completion of the course satisfies Florida's requirement for boat operators to obtain a Florida Boater Safety Education Card. (Required by Florida law for anyone born on or after 1 Jan 1988 operating a vessel with a 10 hp motor or greater.)

Cost for the class is:

\$45 per person

\$60 per couple sharing workbook

\$25 per middle or high school student

The challenging year 2022 is over...and GFWC Rotonda West Woman's Club welcomes in 2023 with renewed enthusiasm. 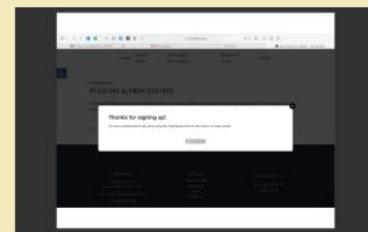
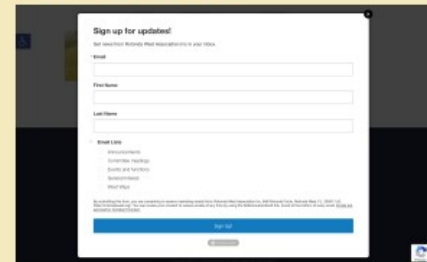

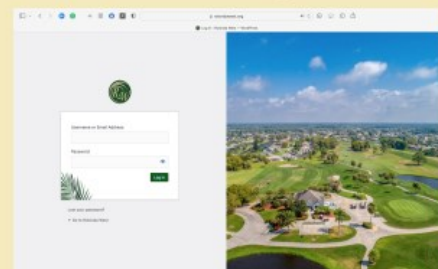
