Member Input on Agenda Items

Members spoke to the need for rules or restrictions for rental properties as well as members speaking in favor of rentals in Rotonda West. Other members spoke to storage units, signs, site screens and pool fences.

Old Business

Craig Fink has resigned from the Ad Hoc committee.

The committee voted unanimously to end discussions of rental restrictions and recommend a member survey to determine if there is membership support for rental restrictions in Rotonda West. The recommendation will be discussed with the BOD during the upcoming workshop. The survey should include an explanation of the pros and cons of rental restrictions and a selection of minimum time periods for any restrictions.

New Business

The committee discussed the possibility of allowing sheds and storage units. A three member workgroup will meet to research the issue and present to the committee at the next meeting. The committee also discussed revising and better defining the nuisance section of the deed restrictions, pool fences, no trespassing signs and site screen height.

Committee Input

Tine Kissane said she has received fifteen emails from three people regarding no rental restrictions. She also said that owners of vacation home rentals are required by Florida statute to obtain a business license but there are only 246 licenses in Rotonda West and 20 are duplicates, so many rental owners are not in compliance with the Florida statute.

Karen Hoover thanked Tina for her work on researching rentals and that is unfair of people to criticize her for her efforts.
