NEW BUSINESS & COMMUNICATIONS –

MEMBERS INPUT (Non-Agenda Items)

Ms. Joan Smith approached the Board with concerns about downed trees between the back of her property and the golf course property. Ms. Smith stated that there has already been a fire due to the downed trees and is concerned that if the debris catches fire again it will be much larger than the recent fire that occurred in March of this year.

Manager Hedges noted that the golf courses are being cleaned up, but it is a slow process as the number of downed trees and debris is overwhelming.

Ms. Sylvia Johnson questioned who owns the swale between her property and the golf course where downed trees remain and have not been cleared yet.

Manager Hedges suggested looking at a survey of the members' property lines to determine whose property the trees are on. Again, Manager Hedges stated that the golf courses are being cleaned up, but it remains to be a slow process and suggested that members please call the golf course.

Ms. Susan Pieri addressed the Board with a request for the RWA to allow sheds in our community and asked if perhaps the By-Laws could be amended to allow members to put up sheds on their properties. Ms. Pieri stated that she had a shed on her property that was "grandfathered in" and

it was destroyed during Hurricane Ian and would like to replace it as she needs a place to store her belongings.

President Van Scyoc stated that he would love to have a shed himself, however, unless the structure was built before 1995 the rules are that there are no free-standing structures allowed. This is a request that has continually been brought up, however, until the Developer changes the Deed Restrictions sheds will not be allowed in our community.

Ms. Donna Stogsdill asked the Board if the RWA has a Mission Statement and if so where it is located. A statement was asked on social media about what is RWA for or what is it that the RWA does.

Ms. Stogsdill also requested attendance from the Board members at the Meet & Greet events. Voting people in our community need to meet and know who their Board members are.
