Director Metz announced that there will be a BOD & Budget & Finance Workshop will be held on October 12, 2023, at 12:30 PM.

<u>Buildings & Grounds</u> – Director Besase (Chair)

Director Besase made a Motion to approve RWA Manager to proceed with RWA
 Community Center south area concrete pad project at a Not-to-Exceed cost of
 \$45,000.00 based on the preliminary bids & specifications. Completion to be within 90
 days of RWA BOD approval. Director Cowin 2nd the Motion. Motion Unanimously
 Approved.

Director Besase noted the previous Board approval for the RWA Manager to procure up to 2 used trucks depending on the used truck market at up to \$25,000. One truck was procured for about \$10,000 about 18 months ago.

The RWA Manager has found another used truck (Toyota tundra) at a good price of \$9,000, therefore, based on the authorization of a couple of years ago the RWA intends to purchase this used Toyota Tundra truck. Note the purchase of both trucks is under the \$25,000. This is a notification to the RWA BOD.

Community Outreach – Deb Orchard (Chair)

- Director Cowin made a Motion for the approval to bring live animals into the Community center as part of the Community Outreach Committee's presentations only. Director Harvey 2nd the Motion. Director Besase noted that "Live Animals" should be listed on the Community Center Application when requesting approval for an event. Motion Unanimously Approved.
- Director Cowin made a Motion to approve use of Parade Budget Funds to purchase items if they aren't donated. Total not to exceed \$800.00 out of total budget \$3,550.00 budget. Director Besase 2nd the Motion. Motion Unanimously Approved.

NEW BUSINESS & COMMUNICATIONS –

President Van Scyoc opened discussion of parking of street legal golf carts.

Director Cowin stated that she herself owns a Low-Speed Vehicle (street legal golf cart), and is able to park her L.S.V. in her garage, however, some members that own L.S.V. may not have room in their garages and may need to park them in their driveways, and feels that as long as the vehicle is registered as "street legal" members should be allowed to park their L.S.V. in their driveways. Also, when using their L.S.V. while visiting someone she does not feel that if she parks her vehicle in a person's driveway that that should be a violation and requests clarification of Section 24 of the RWA Deed Restrictions.

Director Besase emphasized that these "street legal" golf carts be referred to as Low-Speed Vehicles and must have the requirements to deem them as L.S. V's.

Director Goodman requested that Low-Speed Vehicles should go through a registration process and questioned how Compliance will enforce the parking of a L.S.V. vs. a golf cart.

A lengthy discussion was held regarding visibility and example setting in a possible change to the Deed Restrictions.

MEMBERS INPUT (Non-Agenda Items)

Mr. Coffee announced his appreciation to all the volunteers that work diligently on the Hurricane lan canal clean-up and offered a proposal that the RWA would show recognition to all the volunteers that helped with the clean-up project.

Director Besase noted to take the idea to the Community Outreach Committee and possibly include them in the Volunteer Appreciation Banquet.

Ms. McDowell addressed the Board and noted the new state L.S.V. requirements that go into effect on October 1, 2023, and requested that these new requirements be sent out to members of the community.

Director Besase noted that he believed there may be an article in Westways regarding golf carts.
