On Thursday, October 19th, association members gathered at the Community Center to meet the four candidates, namely Jerry Eldred, Karen Harvey, Dale Jensen, and David Kelly, who are running for election to serve on the RWA Board of Directors.

The event was an opportunity to hear the candidate's thoughts, proposals, plans, and goals for the future of the Rotonda West Association. All questions were previously submitted to the Election Committee, and were reviewed by the Election Committee beforehand.

The well-organized program lasted two hours and was attended by many interested voters, both in-house and on zoom. Chairperson RoseAnne Woodliff explained the evening's agenda and stated that the program would be divided into three sections: introductions; questions and answers; and closing statements. Time limits would be followed for each candidate's comments.

#### **CANDIDATE'S NIGHT CONTINUED**







The four candidate's answer questions

The candidates were first introduced to those in attendance and those on zoom. Then each candidate gave an opening statement about themselves lasting 2 minutes. Jerry Eldred stated that he and his wife have lived in Rotonda for eight years and loves this community. He stated that he has a history of public service, and that "public service" is in his blood". Karen Harvey stated that she and her husband have lived in Rotonda for five years, and she has served and chaired several committees. One of her campaign focus is on modernization and moderation of deed restriction guidelines. Dale Jensen stated that he has lived in Rotonda 10 years, and has served on many committees. He is focused on deed restriction guidelines and modernizing residential modifications, and also wants prudent financial decisions to continue to be made. David Kelly stated that he and his family have lived in and around Rotonda West for 40 years. He adds that he is the "common sense" candidate, and that he understands the needs of the community.

The second portion of the program centered on answering the questions that had been submitted by RWA members. Some of the questions were candidate specific, and some were general questions for all the candidates to answer. The time limit on answering these questions was set at 3 minutes. During the two hour event, several questions were discussed by the candidates. The concerns of the community members were evident in the questions that were submitted. The approximate topic breakdown of the 50 questions asked were as follows:

One of the general questions asked was" If you had a magic wand, what one problem would you fix in Rotonda?" Jerry Eldred stated, "Landscape Stone. I would like deed restrictions modernized and changed." Karen Harvey answer to the Magic Wand question was, "That people would look at deed restrictions with the spirit that is intended, which is to keep property value high." Dale Jensen stated that, "I would wave it to ensure compliance with the deed restrictions." David Kelly would use magic wand to "Fix drainage problems in Rotonda, and to have all the bridges done at once."

The last portion of the program allowed the candidates to make closing statements. After restating key points of their campaign, candidates thanked the Election Committee for sponsoring the Candidate's Night event, thanked the community for submitting interesting and relevant questions, and thanked the audience, both in-house and on zoom.

#### **BOARD CONSIDERS DEED RESTRICTION ISSUES**

The Rotonda West Association Board of Directors met as scheduled on October 26. A major part of its meeting time was spent the ongoing review of Deed Restrictions and Residential Modification Guidelines.

Presumably, most of our readership is aware that Rotonda West is a deed restricted community; that is, property owners are subject to certain rules and restrictions that are written into their deeds to their properties. Perhaps less widely understood is the process, under Florida law, whereby deed restrictions come into being and how they can be modified. When a Developer (usually a corporation) proposes to establish a subdivision or residential community, he or she must determine whether it is to be deed restricted, and if so, must prepare the deed restrictions to be written into all deeds to property in the development. Initially, the Developer must approve all changes to the deed restriction but at some point as the community matures, this authority can be transferred to the property owners of the community. Then it will require a majority vote of the property owners to make any change in the deed restrictions.

Rotonda West was first developed in the 1970s, and in the intervening five decades most of the Developer's prerogatives have been devolved to the property owners, to be exercised largely through the RWA. However, the power to establish and change deed restrictions has remained with the developer. Over the last year or more the RWA Board has been negotiating with the Developer's representatives to bring about this transfer of authority. On several occasions the Developer has indicated that the transfer is imminent, but so far it has not happened.

Over that same period of time, the Board and its supporting committees, including an ad hoc committee established for the purpose, have developed a number of proposed deed restriction changes. Some of these have been approved by the Board and sent to the Developer for approval, but they have not been acted on. Others remain under review within RWA. After consideration by an Ad Hoc Committee established for the purpose and at a joint workshop between the Board and the Ad Hoc Committee on October 19, a proposed amended set of deed restrictions came before the Board for consideration at its October 26 meeting. However, it did not receive Board approval. Instead, another workshop was scheduled on November 2 to discuss recommended changes.

This workshop, involving the Ad Hoc Committee and the Board of Directors, will be held at 10 AM on Thursday, November 2, at the Rotonda West Community Center in Broadmoor Park. All interested Rotonda West property owners are welcome to attend.

#### NEWSLETTER EVOLVES WITH READER PLEASING FORMAT

As you read our West Ways newsletter, take note of the easy-to-read format, cool colors and appealing graphics. The reader friendly format didn't just happen. It evolved-- all under the capable leadership of Nadine Clough.

After moving from upstate New York to Rotonda West in 2012, the former elementary school teacher saw a notice in West Ways asking for writers. Since she always loved writing she thought it would be a perfect way to get involved in the community. She thrived writing stories for several years for West Ways then stepped up, when needed, to also take over the editor's role and the job of layout person.

Her prior experience putting out the Staghorn newsletter for the Rotonda Elks prepared her for her new role. But nothing could prepare her for the problems she faced. She states, "I took the job of editor of West Ways in August of 2020 at a critical time. By necessity RWA knew it was time to stop sending the newsletter by mail, a process that was costing close to \$10,000 per mailing. Members had enjoyed getting the newsletter in their mail, and did not sign up for the free email delivery of the newsletter. Our circulation started to drop. Then COVID hit and everything came to a standstill. During this time, RWA was also updating its website and was ironing out technical problems which made it difficult to find West Ways online. Readership fell to a low of about 400 members. West ways was on life support."

The good news is it was revived and came back to life better than ever. One by one, with Nadine's persistence and focus on staying upbeat, problems were solved. The newsletter evolved into its present attractive format. The climbing circulation tells the tale. There are now more than 4,000 readers. At the start of every month when the new issue arrives in e-mail, RWA residents have learned they can easily find upcoming events as well as important information they need to know—all in an interesting format.

While Nadine makes it look easy, that belies the long hours she puts in planning each issue, working with writers and finding appealing graphics to accompany the articles. She credits her staff of writers, photographers, volunteer contributors, and members of the RWA Community Outreach Committee with helping to make the West Ways newsletter a success.

#### FAIR WINDS AND FOLLOWING SEAS-A LIFE IN BALANCE

An Interview with Dr. Frank Levin

On Wednesday, November 15th, Dr. Frank Levin, a Rotonda West resident, will be offering a lecture on Global Warming-Truth & Consequences. This lecture is one of a series he has done at the RWA Community Center. Other lectures in the series include: Microwave Ovens and Our Expanding Big Bang Universe; Symmetry in Nature-Art and the Laws of Nature; Atoms are Real, Aren't they?; and Most Important Minus Sign in the Universe. Dr. Levin is a theoretical physicist known for his research on nuclear reaction theories, few-body physics, multiparticle scattering theory and its application to

atomic and molecular structure.

Frank was born in New York City in 1933, and grew up in Baltimore, Maryland. His father was a factory-worker, and his mother a stay-at-home mom. He attended Johns Hopkins University where he earned his A.B. in physics, and the University of Maryland, receiving his Ph.D. in physics in 1961. Professor Levin joined the Brown Physics Department in 1967, where he taught both undergraduate and graduate physics courses until his retirement from Brown in 1998, becoming an emeritus professor of physics.

Dr. Levin has an impressive resume. He has worked on several postdoctoral scientific research projects at Rice University, Brookhaven National Laboratory,

and the Atomic Energy Research Establishment in England. He has been a visiting professor in places such as Bonn, Budapest, Delhi, Gainesville, Lisbon, Mexico City, and Quebec. He has received various awards, and is the founder and first Chairman of the American Physical Society's Topical Group on Few-Body Systems and Multiparticle Dynamics. Dr. Levin has also written, co-authored, and edited various technical books and has written three popular science books.



There are many examples of artwork displayed in his home, from pieces of art gathered from his travels, to cherished paintings done by his late wife, Carol who was an artist. He is also an avid reader, enjoying books and international news in the NY Times.

Frank is a man who exemplifies the belief that happiness and fulfillment are had by always moving forward. Nothing proves this more than his love of sailing. Frank and Carol owned their sailboat, CHEERS for 18 years, purchasing it in 1988. Frank states, "Carol had wanted a sailboat with three separate interior spaces, but when I showed her CHEERS, she, like me, fell in love with it. We sold our Providence, RI house to pay for it."

Frank and Carol shared many sailing adventures together.

When asked his most memorable, he stated, "There is not a single-most memorable sailing experience: there are too many."

He recounted how they would circumnavigate Aquidneck Island

(in Rhode Island). This became an annual event prior to CHEERS being stored for winter. They also sailed from Rhode Island to the Bahamas during his sabbatical from Brown in 1989-1990. In 1992, he sailed to Bermuda and back with three friends. Another sailing voyage, in 1996, brought him from Portsmouth, RI to Castine, ME where he stayed several weeks, during which time he wrote Chapter 13 of his undergraduate quantum textbook.

Carol was an experienced sailor whose ability, insight, and intuition made her essential to their sailing adventures. Once, Frank recalls, they were threatened by the captain of a huge fishing boat when anchored in Cape Porpoise, Maine. Whereupon Carol appeared in the cockpit, soothing the angry captain down and then managing to get directions to re-anchor. As an example of her intuition, she insisted that the life-raft be removed from a cockpit locker and secured on deck. As it happened, the on-deck life-raft self-inflated and thus did not damage CHEERS.

Dr. Levin is a strong advocate for being a life-long learner. For eighteen years, before moving to Rotonda West, he taught several weeks-long science courses in lifelong learning venues for persons with neither a math nor science background. Today, Dr. Levin keeps active in his field by

lecturing at the RWA Community Center on scientific topics, and by continuing to write books. Frank's newest book, <u>Global Warming-Truth</u> & Consequence, A Primer, is currently being released.

As the nautical blessing says,

"May you always encounter fair winds and following seas."

It is hard to believe that Thanksgiving is right around the corner; my favorite holiday by the way!. Soon to be followed by Christmas, Hanukkah, and Boxing Day (for all our Canadian friends), just to name a few. No matter what you will be celebrating, just remember there are opportunists out there looking for an opportunity to take advantage of us. Recently, just outside the "Circle of Rotonda" there was a string of burglaries and property damage caused by a few individuals that live in Rotonda West; in fact, within the "Circle of Rotonda". The good news is that they were captured and now must suffer the consequences. But what about those affected by the dereliction of these individuals; they still must piece together their broken property and replace stolen items. Below are a few reminders to keep your valuables safe.

#### At Home:

- o Make sure all doors and windows have secondary locks (window pins, deadbolts, dowels, etc.) and use them!
- o Don't hide spare keys in mailboxes or planters, or under doormats.
- o Ensure that dark areas and entrances have outdoor lights that are turned on after dark or are activated by sensors.
- o Keep trees and shrubbery trimmed so they do not conceal doors and windows. Remember, overgrown foliage can provide a hiding place for criminals.
- o Place gifts where they can't be seen from the outside.
- o Be sure to mail cards, checks or gift certificates from the Post Office or at a blue U.S. Postal Service collection box.
- o Lock your vehicle and remove all the valuables. **Yes, even in your driveway.**

#### **Strangers at your Door:**

- o Use caution anytime there is a stranger at your door.
- o Be suspicious of unexpected sales calls or deliveries. Ask for identification.
- o Be aware of scams that criminals commit to take advantage of people's generosity during the holidays.
- o Investigate charities before making donations. Ask how the funds will be used.

#### **Leaving for the Holidays:**

- o Ask a trusted friend, neighbor or Neighborhood Watch member to watch your home.
- o Use timers for lights and radios while you're away.
- o Remember to make arrangements for mail and newspapers.

# ASK THE PHARMACIST RETURNING IN DECEMBER

Hello to you!

I hope the transition into the fall months finds you all well! A friendly reminder that we are now in the Medicare Open Enrollment season! If you need to renew or update your benefits, make sure to check in with a broker or call 1-800-MEDICARE to inquire about next year's plans and opportunities. The plan you have right now may change, or you may be eligible for some new benefits. Be prepared to discuss your financials and current healthcare needs. It's important to remember that our health can change in an instant... be mindful not to under-insure yourself with the idea that you want to save a few dollars. Too often I have seen patients hit hard later financially because they didn't buy enough insurance. If you're unsure how to find a broker, often times there are individuals in the pharmacies or big box stores who can help. Sometimes the senior center, your peers, or even a Google search might offer some options.

The next "Ask the Pharmacist" event will be offered on December 7 at 3pm in the RW Community Center. This will be a discussion group format where we share information together. There will be two parts: one featuring how to read labels on OTC medications, the second will be called "Proceed with Caution", where I share stories of common behaviors that may lead to unintended consequences. I encourage you bring an OTC item from home, for us to use as an example for the first part of the discussion. As before, you are also invited to bring anything that makes you comfortable for our hour visit: friends, layered clothing, a pen and paper, a beverage....

Also I will collect self care items to share amongst those in need within our community - think "dollar store" perhaps.... Soaps, shampoo, feminine hygiene...







#### **RULES & REGULATIONS**

- 1. Arrive on time --- staging begins at 8:45 am. Plan to arrive at staging area between 8:30am and 8:45 am. The parade begins promptly at 10:00 am. A bullhorn announcement will be made 10 minutes before the parade begins. The fire truck will sound its siren at the start of the parade.
- 2. Candy, beads, and other items cannot be tossed from any vehicle.
- 3. Stay in the assigned order unless specifically directed by a parade official.
- 4. Follow a straight course along the route in a cautious and safe manner.
- 5. Riding on and/or jumping from the hood, roof, trunk, or door frames of any vehicle is prohibited.
- 6. Sound systems should be placed with speakers facing the sides of the unit to minimize interference with other parade participants.
- 7. All units/vehicles must proceed past the end of the parade route to disembark location at the Rotonda West Community Center before stopping and/or unloading. Breakdown of floats cannot be completed on the roadway.
- 8. Units will have the opportunity to temporarily stop in the judge's zone for viewing and judging. If entertainment is part of your participation, you will be limited to thirty (30) seconds to perform, otherwise keep the procession moving.
- 9. Santa impersonators are <u>strictly prohibited</u> and will be asked to either remove the costume or leave the parade. There are NO EXCEPTIONS.
