'ADMIRAL ANDY' AND VOLUNTEERS LIBERATE ROTONDA'S CANALS FROM HURRICANE IAN

Following Hurricane Ian that devastated southwest Florida on September 28, 2022, the one part of Rotonda West that had yet to recover was its 23 miles of canals.

Andy VanScyoc, best known as president of the Rotonda West Association Board of Directors may find more pleasure in his honorary title of admiral of the Rotonda West Yacht Club. In Rotonda West, a yacht more often than not, translates to a pontoon boat. Folks who followed the group's Facebook page, prior to "lan", would find "Admiral Andy" gathering member's pontoons for lighted holiday parades or evening floats. Often, an announcement would go out and any resident would be invited to hop aboard an available "yacht" for a memorable float through the canals.

It was a combination of impatience to get back to that state of enjoyment, knowing that waiting on Charlotte County to start canal cleanup might take years, and understanding that very few people had the equipment or leadership ability to undertake such a project that prompted VanScyoc, last January 24, to post on the Rotonda West Yacht Club page the following message:

Hopefully start cleaning the canals this weekend. We are way overdue, first the county was going to do it, then the state but I think we can get the ball rolling with the awesome volunteers of the yacht club. We will be getting trash and small debris.

Recognizing the size of the project ahead, he added:

In the past I would put together massive fleet efforts and get it done in one weekend but this time the task is way too large for that. I'm just hoping to initiate the process this week.

As it turned out, the project was fully completed in nine months, with the most time spent in the Oakland Hills section – January 24 to April 5 - where tornados during lan deposited all manner of flora, fauna and home debris. It was also VanScyoc's home base, and there volunteers learned valuable techniques for dealing with trash/recycling cans (turn them sideways) or portable toilets (NEVER bring them aboard, instead get them to shore and put them on a truck with a lift gate).

Volunteers next tackled Pebble Beach from April 5 to May 26. On April 11, another of many equipment issues occurred when VanScyoc documented what sounded like a gunshot that blew the hood off the boat engine, igniting a fire that was finally put out with canal water after a fire extinguisher ran out. To make matters worse, the engine hood also sank in the excitement. On the good side, a couple of days before, the volunteers had completed cleanup of 20% of "lan's crap out of our beautiful waterways."

The months of June and July saw a break while VanScyoc recovered from foot surgery but lady volunteers, including Melissa Blayman, did spend the July 4th weekend cleaning up in the White Marsh section.

Cleanup resumed in earnest on August 8 with the Pinehurst, Broadmoor and half of Long Meadow sections of the Rotonda River being cleared. Pine Valley, on August 10, took just six hours to clear its four and one-half miles. White Marsh was completed on August 15, with four creeks left to "finish the whole place for storm debris cleaning". Long Meadow was completed on the 16th.

On August 23, VanScyoc geared up for a final push, targeting upper Broadmoor Creek on the 25th, "I'm not going to sugar coat it, the work is hot and nasty but the satisfaction of being involved in this project is worth it. We are getting close to completion now!!" he wrote on the Facebook page while calling for assistance.

Lower Broadmoor Creek was completely blocked until the volunteers removed trees and made the creek passable on September 1.

The project came full circle on September 5 when all of Rotonda's navigable waterways were declared open. Unfortunately, VanScyoc's vessel overheated and was towed home. "She's broken, nasty and stinky, but she's home and she accomplished her objective," he wrote. On September 14, he posted a photo of the engine that had been presumed dead. It was running. "I'm happy today," he wrote.





A final mission was completed on September 23 when volunteers returned to the Oakland Hills section to clear a particularly daunting bit of storm debris. It was a massive section of metal roofing that was hanging from a tree, down into the Oakland Hills creek.

VanScyoc realized this job would take all of the accumulated experience gained over the nine months of the project. When removed, VanScyoc realized his decision to leave this portion of the project to the bitter end was correct - the metal material measured 37 feet.

In all, over the nine months, VanScyoc estimated the volunteers recovered 60-70 trash/recycling cans and some 60 portable toilets. They recovered so much soffit material he was able to replace

the dodger board – a frame-supported fence that protects boat passengers from waves - on one of his boats with soffit material. While a bowling ball may have been the strangest object recovered, "we pulled a lot of patio furniture out of the canals," he recalled. Another trip recovered a boat bimini top.

VanScyoc utilized two of his own boats during the project and turned one pontoon ("we found regular boats don't cut it") into a specialized cleanup vessel with a blue center mount high towbar for dragging out tree limbs.

Nearly two dozen individuals participated in the cleanup as they could. Some had their own personal storm-related hardships or were seasonal residents. Others no longer lived in Rotonda West. In the case of one volunteer, VanScyoc theorized their motivation was a love of wildlife. He recounted an alligator that even seemed grateful and remained still while that volunteer removed a plastic bag from its back during one cleanup event. "It was almost like it was thanking us," he said.

Looking back on the project, VanScyoc said, "originally, I didn't intend to do the entire canal system...Charlotte County should have done it but they had to concentrate on major salt water areas. I knew I could do it...It needed to be done."

Thanks to Admiral Andy and a host of Rotonda West (and other) volunteers the canals, once again navigable, have been liberated from Hurricane lan.

BOARD OF DIRECTORS MEETING, THURSDAY SEPTEMBER 14, 2023 2PM

ROLL CALL: ALL DIRECTORS PRESENT

APPROVAL OF MINUTES: August 17, 2023 MINUTES

MEMBERS INPUT: brought forward were issues related to signage guidelines.

OFFICERS, EMPLOYEES, CONTRACTORS REPORTS:

- President Van Scyoc-expressed condolences to Derrick and Meghan Hedges on the passing of Meghan's mother.
- Treasurer Besase-stated initial budget for 2024 is being developed; 97% of members have paid assessment; 3% of members are delinquent. Overall, RWA is in an excellent financial position.
- Manager Hedges-stated the office staff continues to complete mowing cycle, and that removal of Brazilian Pepper Trees is proceeding. Manager Hedges also reminds members that grass clippings should not be mowed into canals, or dumped into canals, as it will cause algae issues. Allow clippings to stay on lawn, nutrients will help lawn. Manager Hedges also stated that 3 and 1/2 miles of shell will be put down on pathways in Broadmoor Park sometime in October-November when clean-up is completed.

COMMITTEE REPORTS:

- Discussion of sending out certified letters to members regarding deed restriction violations. Many people state that they did not receive warning letter about violation. 947 violation letters were sent out, 133 letters were ignored. 80% of violations are in 4 categories (trash cans, parking, pepper trees, & exterior projects performed without Residential modification application approval). Report that Residential Modification informational meeting (town hall style) may be held in late October.
- Residential Modification reports that 168 applications reviewed. 98% approval rate, 1-2% not approved (often approved on resubmittal). Reminds members that RMA process works.

NEW BUSINESS AND COMMUNICATIONS:

- Applications (3) for use of common areas: Woman's Club Food Drive 9/30; Campaign Event at Marina 10/15; bridal shower 10/22. All passed.
- Campaign signs allowed at entrance to Broadmoor Park. Item passed.
- FAQ regarding fiscal issues held

BOARD DEBATES GOLF CARTS, "LOW SPEED VEHICLES"

The Rotonda West Association Board of Directors met on the second and fourth Thursdays of the month (September 14 and 28), its normal schedule. For the most part, these meetings dealt with routine business and committee reports, but at its September 28 meeting the Board scheduled a discussion of whether golf carts can be parked in residential driveways, visible from the street. The subject apparently was seen as relevant because a small number of Rotonda West residents have been cited for RWA parking violations on this basis. The Rotonda West Deed Restrictions do not include golf carts in the categories of vehicles that may be parked in driveways.

The scope of the discussion quickly expanded, however, when it became apparent that two classes of vehicles are involved, golf carts, and "low speed vehicles," which more often than not look like golf carts. Florida law defines a low speed vehicle as a four wheeled vehicle with a top speed of more than 20 but less than 25 miles per hour, which complies with the state's safety standards and equipment requirements. Low Speed Vehicles must be licensed and insured, and must be operated by a licensed driver. They may be operated on public roads where the posted speed limit is 35 miles per hour or less.

Golf carts which do not meet the definition of Low Speed Vehicles have a top speed of less than 20 miles per hour and are not subject to state licensing, insurance, safety and equipment requirements. They may be operated on roads with speed limits of 30 miles per hour or less that have been designated by the county as authorized for golf cart use. Prior law permitted those 14 years of age to operate golf carts on authorized public roads. However, a recent change to the law, effective July 1, 2023, requires that such operators be at least 15 with a learner's permit, 16 with a driver's license, or 18 with any government issued ID. At present, though, these provisions are of only academic interest in Rotonda West, because no public roads in Rotonda West have been authorized by Charlotte County for golf cart use.

All of these matters were discussed at the September 28 Board meeting but no action was taken or formally proposed. It appears that the RWA Deed Restriction Committee will place this topic on the agenda for its next meeting to explore what, if any action may be needed. The Deed Restriction Committee normally meets at 9 AM on the fourth Wednesday of the month; its meetings are open to all RWA members.

FRIENDLY REMINDER TO THE RWA MEMBERSHIP

FROM THE

DEED RESTRICTION COMMITTEE

From Dale Jensen, Chairman of the Deed Restriction Committee

Over the past 12 months, the deed restriction committee has found that 80% of the deed restriction violations in Rotonda West fall into four categories:

- Garbage and recycling containers.
- Illegal parking.
- Exterior modifications performed without an approved Residential Modification application.
- Unimproved lots with invasive, non-native vegetation, e.g., Brazilian pepper plants, melaleuca, present.

With that in mind, we would like to take this opportunity to remind you of the rules and regulations pertaining to those categories.

Garbage and recycling containers (Reference: Amended Restatement of Restrictions for Rotonda West, Section 18, Garbage and Recycling/Outside Equipment).

Except on the day immediately preceding the day of collection and the day of collection, garbage and recycling containers shall be kept either inside the garage, behind land-scape shrubs or within a fenced area. In Rotonda West, the normal day of collection is Tuesday which means you can place your containers outside on Monday but must return them to a place of concealment by end of the day Tuesday. (Reference: *Amended Restatement of Restrictions for Rotonda West, Section 18, Garbage and Recycling/Outside Equipment*)



Illegal Parking (Reference: Amended Restatement of Restrictions for Rotonda West, Section 24, Vehicle Operation and Parking, Subsections b, c and d).

All vehicles, other than automobiles, pick-up trucks, SUVs, vans, motorcycles or other vehicles as may be approved from time to time at the sole discretion of the

Grantor/Developer or Association must be parked in a fully enclosed garage. Any vehicle containing any commercial advertising signage parked on a driveway overnight cannot exceed four wheels. Box trucks are prohibited.

No vehicle may be parked on any lawn, road right of way, easement or Unimproved Lot/Tract, except on a temporary basis, not to exceed twelve (12) hours, and only for the necessary construction, repair or maintenance of an Improved Lot/Tract or Unimproved Lot/Tract. Approval from the Owner of the Unimproved Lot/Tract must first be obtained before parking on an Unimproved Lot/Tract.

Any vehicle not required to park in a garage must park on a driveway, or on a contiguous turnout or turnaround area. A driveway or a contiguous turnout or turnaround area are defined as a concrete surface or paver bricks that provide continuous access to a garage except for expanded driveways as herein provided.



Exterior modifications performed without an approved Residential Modification application (Reference: Rotonda West Association, Inc. Residential Modification Committee Guidelines, Section 1, Exterior Additions, Alterations and Modifications).



A Residential Modification Request form must be submitted, reviewed and approved by the Residential Modification Committee (the "RMC") prior to making any additions, alterations or modifications to any Dwelling, Addition, Accessory Structure or Improvement on a Lot/Tract within Rotonda West. **There is no charge for submission of a request form,** however, a Deed Restriction Violation Fee of \$50 for the first offense and \$100 for subsequent offenses will be levied for any work started or completed prior to RMC approval of an RMC request. You may view or download the Residential Modification Application on the Rotonda webpage under "applications & forms".

Unimproved lots with invasive, non-native vegetation, e.g., Brazilian pepper plants, melaleuca, present (Reference: Amended Restatement of Restrictions for Rotonda West, Section 16, Dwelling Maintenance, Landscaping and Lot Care, Subsection b).

Any unimproved Lot/Tract not containing a Dwelling or other Improvement shall be maintained so that no refuse or unsightly objects shall be placed or allowed to remain on the Lot/ Tract and the Lot/Tract shall otherwise be maintained in compliance with local government ordinances and regulations and Rules and Regulations adopted by the Association from time to time regarding the maintenance of natural vegetation and limitations or prohibitions regarding invasive non-native vegetation, including but not limited to Brazilian Pepper and melaleuca and any other unsightly objects as determined by the Board.

The Rotonda West Association staff is very knowledgeable about deed restriction rules and are here to help you with any questions or concerns regarding these rules. Every attempt will be made to help homeowners follow the rules and correct any violations. It is important to remember that even if you receive a violation letter, you are still allowed so many days to correct the violation before a fine is levied.

Because you chose to live in a Deed Restricted community, you have the responsibility to both know the deed restriction rules and, of course, to abide by them.

CHARLOTTE COUNTY NEWS AFFECTING ROTONDA WEST RESIDENTS

COUNTY COMMISSIONERS TO HAVE TERM-LIMITS?

A bill was recently filed to consider term limits on county commissioners. The bill was filed by Rep. Michelle Salzman, R-Pensacola. If approved by both chambers, the proposal would go on the ballot in the November 2024 election. It would require the approval of 60% of Florida's voters. The bill states that it prohibits "incumbent members who have held office for preceding 8 years from appearing on a ballot for reelection". This would apply to terms beginning on or after November 5, 2024. The bill's language is open to legal interpretation and may be different in different counties as dependent on their charters.

NEW LAW RAISES LEGAL AGE TO DRIVE A GOLF CART

Beginning October 1st, 2023 a new Florida law goes into effect for operation of golf carts. The law prohibits a person under 18 from operating a golf cart on certain roadways, unless they have proper identification. The new legislation requires that the driver carry a government-issued I.D. such as a driver's license.

APPROVAL OF REDUCED MSBU RATE BY CHARLOTTE COUNTY COMMISSION


The new fire service rate will be approximately a \$31 increase for the next fiscal year, then a \$28 increase in 2024-2025 for a total increase for the two years of \$59. The original plan would have seen a total increase of \$67. The new rate was approved by the Charlotte County Commissioners after a public hearing. During the hearing, Charlotte County Fire Chief Jason Fair stated that the county's Fire/EMS received 37,868 calls in 2022, which is an 18% increase over the past five years. The funding raised through MSBU rates would help with staffing three new stations in the county. Also, a total of 40 new positions, including new captains, will be added from 2024-2028.

SPRING TRAINING BACK AT CHARLOTTE SPORTS PARK

Charlotte County Facilities project manager Travis Perdue stated that the Charlotte Sports Park was on schedule to reopen by early 2024. The Tampa Bay Rays who rent the facility from the county for spring training have been unable to use the park due to damage caused by Hurricane Ian. The Ray's Baseball Foundation helped with the restoration by presenting a check for \$1 million donation to aid in recovery efforts. Robbie Artz, the foundation's vice president, said he looked forward to the team's return to Charlotte Sports Park in the upcoming months.

FOOD INSECURITY

The USDA defines food insecurity as a lack of consistent access to enough food for every person in a household to live an active, healthy life. This can be a temporary situation for a family or can last a long time. Food insecurity is one way we measure how many people can't afford food. More than 34 million people, including 9 million children experience food insecurity in the United States.

CAUSE

Many Americans struggle to meet their basic needs, which increases their risk of food insecurity. For example, lay-offs at work, unexpected car maintenance, or an accident can suddenly force a family to choose between buying food and paying bills.

The causes of food insecurity are complex. Some of the causes of food insecurity include:

- · Poverty, unemployment, or low income
- · Lack of affordable housing
- Chronic health conditions or lack of access to healthcare
- Systemic racism and racial discrimination

EFFECTS

Food insecurity can have a wide impact, depending on someone's circumstances. Here are just some examples of the effects of food insecurity:

- Can cause serious health issues when people have to choose between spending money on food and medicine or healthcare
- Can make it more difficult for a child to learn and grow
- Can lead to difficult decisions like choosing between food and rent, bills, and transportation


