# Annual Election Absentee or Mail-in Ballot Due on December 6, 2023

### Submitted by the RWA Election Committee

Every year we request your vote for two (2) open Board positions and Rollover of Excess Membership Income over Membership Expenses. The Board of Directors recommends a vote in the favor of rollover as provided by IRS Ruling 70-604 (See page 3 for rollover explanation).

Candidates Information sheets and ballots were mailed to you. All Candidates' Information sheets are also available at rotondawest.org under Governance, RWA Elections. Absentee ballots have specific instructions to follow. Please read them carefully and follow exactly to ensure your vote counts. You may vote for one but no more than two individuals.

If you submit a blue envelope without the white outer envelope, your votes will not count. Contact the office to get a new ballot and process correctly. Only ONE BALLOT per lot shall be counted.

If you submit multiple blue ballots or blue envelops into one white envelope, only one ballot shall be counted. Only ONE BLUE BALLOT per white envelope is counted. Use your envelopes as outlined in the instructions. You must sign the white envelope.

If you did not follow the directions included with the ballot, lost or discarded your hard copy, please contact the RWA office at (941) 697-0788.

# EXPLANATION OF "ROLLOVER OF EXCESS RWA HOA FUNDS" WHICH APPEARS ON THE BALLOT EACH YEAR



Property owners are asked each year as a part of the RWA election process to VOTE either YES or NO to rollover excess funds. Here is Geoffrey Lorah's (RWA's outside independent CPA auditor) explanation:

- Common interest realty associations (primarily condominium and property owner / homeowner associations) are organized as not-for-profit corporations. For operating purposes, it is assumed the annual budgets for these associations will be prepared on a break-even basis, meaning expenditures will equal revenues. When an association has excess member revenue in any given year, there are three basic options available to the association regarding the treatment of the excess revenue:
  - A. Refund the excess revenue on a pro rata basis to the members of the association
  - B. Obtain member approval to "rollover" the excess revenue to the subsequent fiscal year
  - C. Retain the excess revenue and report this revenue as taxable income on the association's Federal and/or State tax return
- If the members do not approve the rollover of the excess revenue, an association has two options regarding the treatment of the excess revenue; either refund it to the members or report it as taxable income.

Please note: This is a general explanation. The rollover process is primarily based on the requirements of IRS Revenue Ruling 70-604

**Did you know** that you can go to Rotonda West association website and complete an application to have your exterior home improvement project approved without leaving the comfort of your home? The process is simple and efficient. <u>www,rotondawest.org</u>

Hard copies of the Residential Modification Application can be found in the administration office at 646 Rotonda Circle or on the website.

If you have difficulty, all you need to do is call the office (941-697-6788) and talk to one of the staff, or email: <u>Tammy@rotondawest.org</u> and we will get clarification or the guidance you need.

### **Helpful Hints:**

If it is alive...flower, grass, plant or tree no application approval is required. *If you want to accent your landscape* project with curbing, rock, shell, or stone you will need an application approval.

The RMA (Residential Modification Application) is not a permit - it is an application for approval from the Residential Modification Committee. Charlotte County issues permits.

Fascia, Gutters, Soffit and Windows no longer require an approval from the RMC (Residential Modification Committee).

Just because you do not see the project listed on the application, does not mean you will not need approval for it - please contact the Association for guidance!

Please remember:

The Residential Modification Committee will not approve incomplete applications.

A TikTok challenge spurs rise in thefts of Kia, Hyundai cars. Your Kia could be stolen with a USB cord: It's that simple.

- Millions of Hyundai and Kia vehicles could be easily stolen—and thousands have—due to a decision not to install engine immobilizers when they were built.
- Popular TikTok videos challenged people to try to steal a car like this, which has led to all sorts of legal and financial trouble for vehicle owners and the two automakers.

Four million Hyundai vehicles—affected Elantras, Sonatas, and Venues—can get a new software fix that introduces a workaround immobilizer starting today. Other affected Hyundais and Kias will get their turn in the coming months.

The backstory, if you don't recall, is that someone figured out that some older Kia and Hyundai models built with a standard key ignition, so not a push-button start, were incredibly easy to steal and created a TikTok "Kia Challenge" encouraging others to try it. The challenge started in Milwaukee before spreading to other parts of the U.S. and forcing Hyundai and Kia to respond.

Today, Kia and Hyundai announced a free, software-based fix for their thief magnets. Kia said the new enhanced security software will "restrict the unauthorized operation of vehicle ignition systems on certain models not equipped with an immobilizer." For its part, Hyundai said the upgrade makes it so that a key fob is required to deactivate the kill switch. Hyundai said the fix would take dealers less than an hour to install. As a bonus to those prospective window smashers, each fixed vehicle "will be affixed with window decals to alert would-be thieves that the vehicle is equipped with enhanced anti-theft technology," Hyundai said.

Kia said its software would be available in the next few months. Kia owners should visit the Kia Owner's Portal or call 800–333–4542 to see if their vehicle is eligible for the fix.

Hyundai has a two-phase release schedule for the new software fix, starting with the 2017 to 2020 model year Elantra, 2015 to 2019 Sonata, and 2020 and 2021 Venue. Hyundai said this category of its best-selling models includes almost four million vehicles. The fix for these vehicles is available starting today. Software for other affected models will be available in June. Hyundai owners should visit <u>https://www.hyundaiantitheft.com</u> to set up a repair, and the automaker said it is also already reaching out to affected owners.

# RWA TREASURER DETAILS FINANCES IN TOWN HALL MEETINGS

Rotonda West Board Treasurer Sam Besase completed the last of three Town Hall Round Table meetings, November 16, with an overview of the finances of the Rotonda West Association. To sum it up, the RWA is on solid financial footing for 2023, with income exceeding expectations by \$67,400 and expenses under budget by \$97,000.

Over the three meetings, some 40 residents attended in person and another 10 attended via Zoom. The meetings are available for viewing at any time on the RWA web site (rotondawest.org) under the Recorded Zoom Meetings/Budget and Finance Committee Meeting link. "The meetings were informative and successful," said Besase. "Plans are to have similar RWA Treasurer Town Hall meetings in 2024."

A major source of income for the RWA is the annual assessment of \$190 per lot – there are 8,040 lots in Rotonda West. That amount has remained the same for seven years and has been adopted by the board of directors for 2024. "You may ask how we can afford to keep it the same with inflation at the rate of 30 per cent," Besase asked? With interest on \$2 million in accounts earning 5.38 per cent, he said the association is earning \$150,000 annually. Other income streams include estoppels, of \$299 each, in fees from the sale of 500-600 new and ex-

isting homes; as well as \$299 each, in fees for property transfers within Rotonda West per year.

Fines for deed restriction violations are another income stream that keeps assessment fees low. A big problem (but not in Rotonda) is reserves. A study of an association's assets valued over \$1,000 is required every three years. Reserve requirements are stringent – ever since the Surfside condominium collapse in 2021. Rotonda has a total of \$1.955 million in certificates of deposit, some covering reserves and some allocated to operations. "We're set for 2024," Besase said. An independent outside contractor shall conduct a reserve study in the first half of 2024. In addition, an independent outside audit is conducted each year and that shall be conducted in the first half of 2024.

Another major income stream is liens and foreclosures. As indebtedness to the Association reaches \$1,000 or more, Besase said, attorneys become involved. Resolution may take the form of a lien on a property or foreclosure, possibly when the property comes to an estate sale. Time to resolution could be three to four years. Some 80 properties are presently involved (roughly 1%), which is a low number, considering the number of lots in Rotonda West.

Major budget expenses of the association are:

- Maintenance of Rotonda West's 35 miles of canals (includes mowing and spraying);
- Mowing a minimum of six times per year of vacant lots;
- Legal fees those for estoppels must be paid monthly "up front";
- Wages/taxes/benefits for up to 12 employees, not all of them full time;
- Property taxes on 30+ RWA-owned parcels (Memorial parks, etc.);
- Licenses plates for RWA-owned vehicles and trailers;
- Insurance like everyone else, the RWA is seeing rates 20-30 per cent higher;
- Audit Performed independently annually by Geoff Lorah, CPA of Punta Gorda;





- Community Outreach Allocated to the Community Outreach Committee for events;
- Election Covers postage and printing to 8,000 lot owners for annual board of directors election – and the Annual Meeting notice (2 mailings);
- Utilities Expenses for heating, cooling, electrical, etc.;
- Community Center A jewel for Rotonda West but configuring the building daily for the many meetings and events takes personnel and time;

Although bridges and roads are not the responsibility of the Association, Besase sits on the Rotonda West Street and Drainage Municipal Benefit Service Unit (MSBU), so is familiar with the issues involving paving and bridge repair, so he also addressed that topic.

There are 17 bridges within Rotonda West and all of them are 50 years old. The Rotonda MSBU has 9,000 lots (8,000 of them within "The Circle" and 1,000 outside) that have been paying continuously for maintenance of swales, pot hole repair, and with the expectation that every 20 years, roads would be repaved. Then, five years ago, the county looked at the bridges and adopted a plan that after engineering and bid letting, six bridges would be repaired every two years, except for the last two years when only five bridges would be left for repair. It was then decided that paving made more sense when the bridge repairs were complete. An advantage to that, said Besase, is that funds are still being collected at a high return of interest rate that may pay for the paving project ahead of schedule.


A pleasant surprise was that none of Rotonda's bridges were in need of replacement. Repair of Rotonda's first three bridges should begin in the last half of 2024. The next meeting of the MSBU is December 7, 9:30 a.m., at the county office on San Casa in Englewood. When Ian hit, the bridge at Rotonda Boulevard South and Rotonda Circle (Bridge 113) was damaged so badly it was closed. It suddenly became a FEMA project and was removed from the scope of the MSBU. Those repairs may not begin until mid-2025. Still, that bridge may not need full replacement.

Besase said he routinely attends Charlotte County Commissioner's meetings and requests speedy repair of Bridge 113, although it has not yet resulted in moving the bridge repair forward. He also lobbies frequently for a traffic light at Gasparilla Road and Rotonda Boulevard East. He has received affirmation from county engineering that the light has been approved by county engineers, but no date for installation has been set. The stop light is probably at least 3-4 years out due to design and planning and bids, Besase said. Charlotte County advises that there are severe supply chain shortages for traffic lights.



I hope the transition into the fall months finds you all well! A friendly reminder that we are now in the Medicare Open Enrollment season! If you need to renew or update your benefits, make sure to check in with a broker or call 1-800-MEDICARE to inquire about next year's plans and opportunities. The plan you have right now may change, or you may be eligible for some new benefits. Be prepared to discuss your financials and current healthcare needs. It's important to remember that our health can change in an instant... be mindful not to under-insure yourself with the idea that you want to save a few dollars. Too often I have seen patients hit hard later financially because they didn't buy enough insurance. If you're unsure how to find a broker, often times there are individuals in the pharmacies or big box stores who can help. Sometimes the senior center, your peers, or even a Google search might offer some options.

# CHARLOTTE COUNTY COMMISSIONERS APPROVE NEW RV RESORT, RESIDENTIAL SUBDIVISIONS

On Tuesday, October 31, 2023, the Charlotte County Commissions approved final site plans for a new RV resort in Rotonda West and two residential subdivisions in Englewood and Port Charlotte. The three locations are as follows:

• CABANA BAY RV RESORT BY BOCA GRANDE in Rotonda West-this project site is located on more than 38 acres at 311 Rotonda Blvd. E. It will have 170 RV units, 2.9 acres of commercial space, a dog park, and a swimming pool.



• ISLAND LAKES AT COCO BAY in Englewoodwill be more than 120 acres south of San Casa Drive, NE of Placida Road, and west of Winchester Blvd. It will contain 222 single-family homes and villas.

• HARBOR EAST in Port Charlotte north of Tate Waterway, southeast of Interceptor Lagoon, and east of Aquarius Waterway. It will have 82 single-family lots on 31 acres.
