Pursuant to FI. Statute 720.305, I move that:

As to any RWA member who, <u>as of today's date</u>, is more than 90 days delinquent in paying any fee, fine, or other monetary obligation due to RWA, the following rights are hereby suspended.

The right of the member, and tenants, guests, and invitees of the member to:

- Serve on the RWA Board of Directors or an RWA Committee
- Access and use of the boat launch ramp at the Marina;
- Rent any room or space at the Community Center;
- Reserve any room or space at the Community Center; and
- Rent any boat slip at the Marina.

The voting rights of the member, including but not limited to the right of the member to vote in the 2024 RWA election process.

These suspensions shall apply even if the delinquency arose from less than all multiple parcels owned by a member.

These suspensions end upon full payment of all obligations currently due or overdue to RWA and the rights enumerated above shall be restored.

The Association shall notify the applicable owners by mail of this policy.
