



## **Administration**

- Collected and processed 24 estoppels and 24 transfers so far this month
- During the week, **91** members visited the Rotonda West Association Office for inquiries and applications
- Contacted property owners through emails, phone calls, and letters about approximately **773** Deed Restriction Violation Warnings. Among

these, **114** violations led to first-time fines, and **5** violations resulted in second-time fines for members who did not address the warnings

- The Residential Modification Committee has been working hard to process and approve 67 applications so far this month. <u>Please make sure to complete</u> your entire Residential Modification Application so that we can process it efficiently, and it will be approved
- Processed 53 parking passes and additional permits so far this week
- This week, we worked with 15 RWA members to help them secure a contract to remove Brazilian Peppers and dead trees on their unimproved vacant lots.
   Initially, 492 unimproved vacant lots were in violation due to Brazilian Pepper
   Trees or dead trees. So far, we have worked with members to clear 186 of those unimproved vacant lots
- 1 Claim of Lien has been released on a property in the Broadmoor section
- Processed and mailed out **20** new homeowner packets this month
- Continuing to pull unapproved signs or posts in the common areas, right of ways, and vacant lots, removing an additional 17 signs this week
- Collected approximately \$350 this week from members who had past-due payments for violation fines and assessments

## Rotonda West Maintenance Staff

- The Maintenance Staff has completed or is completing the following tasks:
- Mowed, treated the weeds, and trimmed the landscaped areas at all of the Memorial Parks
- Mowed, treated the weeds, trimmed the landscaped areas and added some plants to all of the 5 front entrance signs
- Mowing the meadows and common areas around Broadmoor Park
- Mowed and trimmed 1 residential property under Section 16. In the Long
  Meadow sections that are neglected (they are being charged for our services)
