

Administration

- In **November**, we collected and processed **24** estoppels and **24** transfers. So far in **December**, we have processed **1** estoppel and **1** transfer
- During the week, **130** members visited the Rotonda West Association Office for inquiries and applications
- Processed **129** parking passes and additional permits so far this month
- This week, we collaborated with **6** RWA members to help them secure a contract for the removal of Brazilian Pepper Trees and dead trees from their unimproved vacant lots. Initially, **492** unimproved vacant lots were in violation due to the presence of Brazilian Pepper Trees or dead trees. So far, we have assisted our members in clearing these lots, and currently, **288** unimproved vacant lots still need to be brought into compliance.
- The Rotonda West Association Administration Office has been busy **notarizing documents** for our members and is proud to have helped **39** people this month. If you need a document notarized, you can visit the RWA office. This service is offered for **free** because it's one of the ways we can assist you better
- The Residential Modification Committee has been working hard to process and approve **160** applications so far this month. <u>Please make sure to complete</u> your entire Residential Modification Application so that we can process it efficiently, and it will be approved
- Contacted property owners via emails, phone calls, and letters regarding 766 Deed Restriction Violation Warnings. Among these, 92 violations resulted in first-time fines, and 10 violations led to second-time fines for members who did not address the warnings
- Processed and mailed out **17** new homeowner packets this month

- Released 1 Claim of Lien on a property in the **Pine Valley section** for unpaid **Assessments**
- Processed 1 Claim of Lien on a property in the **Pine Valley section** for unpaid **Assessments**

- Continuing to pull unapproved signs or posts in the common areas, right of ways, and vacant lots, removing an additional **6** signs this week
- Collected approximately **\$3153** this week from members who had past-due payments for violation fines and assessments
