- Processed 40 estoppels and 40 transfers so far this month

- Processed 4 Notice of Intent to Claim of Lien on properties due to unpaid deed restriction fines and assessments in the White Marsh and Pine Valley sections
- The Residential Modification Committee has been diligently working to process and approve 173 applications this month <u>To ensure that your application is</u> <u>processed efficiently and approved, please make sure to complete your entire</u> <u>Residential Modification Application</u>
- We have recently received approvals for 4 new construction plan approvals from Cape Cave Corporation and have released 4 new construction deposits this week. This brings our total number of ongoing new construction projects to 225 homes.
 These homes are currently awaiting final occupancy certification under the New Construction Clean Site Program.
- The Board of Directors has approved a resolution that allows members to choose
 to receive materials for voting electronically. So far, 1750 signed applications for evoting have been received. As a result, members will now receive their election
 packets electronically

- This week, we've made significant progress by updating our Section 16. tree removal list. There are currently 105 members remaining on our list who are working to bring their unimproved vacant lots into compliance by addressing issues related to Brazilian Pepper Trees and dead trees. - Continuing to pull unapproved signs or posts in the common areas, right of ways, and vacant lots, removing an additional 20 signs this week

- We've been putting in a lot of effort this week and have kicked off the painting of the
 Administration Building! We're excited to continue next week with the soffit
 painting and trim work that still needs to be done
- Mowed the vacant lots in the Pinehurst and Broadmoor sections and will continue mowing in the Broadmoor sections next week
