- Processed 1 Notice of Intent to Foreclose Liens on properties in the Oakland Hills section
- The Board of Directors has approved a resolution that allows members to choose
 to receive materials for voting electronically. So far, 2,013 signed applications for evoting have been received. As a result, members will now receive their election
 packets electronically

- This week, we've made significant progress by updating our Section 16. tree
 removal list. There are currently 101 members remaining on our list who are
 working to bring their unimproved vacant lots into compliance by addressing issues
 related to Brazilian Pepper Trees and dead trees. If you're interested in finding out

- The Rotonda West Association Administration Office is pleased to offer notarization services for our members. So far this month, we've successfully assisted 38 individuals! We encourage you to visit the RWA office if you need a document notarized. Please ensure your documents are in English to help streamline the process. Remember, this valuable service is free of charge, as we are committed to effectively supporting our members
- Continuing to pull unapproved signs or posts in the common areas, right of ways, and vacant lots, removing an additional **13** signs this week
- Collected approximately \$3500 this week from members with past-due payments for deed restriction violations

Rotonda West Maintenance Staff

- The Maintenance Staff has completed or is completing the following tasks:
- Mowing at the front entrance of Broadmoor Park along with cleaning 3.5 miles of walking paths, branches, and miscellaneous debris
- Mowed and trimmed the grass around the Administration and Community Center buildings
- Mowed, trimmed, and treated the weeds at all 5 front entrance signs from Cape
 Haze Drive to Rotonda Boulevard East
- Spot treated the weeds in the parking lot, landscaped areas, and around the Community Center and Administration building
- Mowing, trimming, and treating the weeds at all Memorial Parks and Gazebo
 Island

- Restored the walking paths in Broadmoor Park by adding material to the washedout sections, ensuring a smoother and safer experience for our members
- We added mulch to improve the area where we previously removed 1,200 square feet of weeds and planted native plants
- Mowed around the intersections along Rotonda Circle and Boundary Blvd of Cape
 Haze Drive, West Blvd, Rebel Ct, North Blvd, and East Blvd
- Removed several dead pine trees and invasive Brazilian pepper species from near L11 and L12 in Broadmoor Park
- Ensuring that all of the **17** dog stations in **Broadmoor Park** and Parade Circle are maintained, stocked with bags, and emptied twice a week.
- Mowed the vacant lots in the White Marsh sections; will continue mowing in the White Marsh and Pine Valley sections next week
- Invasives, grasses, and submersed plants have been sprayed in the canals and areas listed below:
- Broadmoor(Finger lakes)
- Long Meadow(Water lettuce)
- White Marsh(Water Hyacinth)
- White Marsh(Finger lake)
- The Truxor has been cutting and removing Vallisneria and grasses in the following sections.
