- Processed 14 estoppels and 14 transfers so far this month
- Processed and mailed out 12 new homeowner packets so far this month
- Processed 62 parking passes and additional permits so far this month

- This week, we've made significant progress by updating our Section 16. tree
  removal list. There are currently 99 members remaining on our list who are working
  to bring their unimproved vacant lots into compliance by addressing issues related

- Processed and mailed out 10 delinquency letters for unpaid violations and assessments
- Processed 6 Notice of Intent to Claim of Liens on properties with deed restrictions and unpaid assessments in the Pebble Beach, White Marsh, and Pine Valley sections
- Released 6 Claim of Liens on properties with deed restrictions and unpaid assessments in the Pebble Beach sections
- During the week, 89 members visited the Rotonda West Association Office for inquiries, applications, and to make their 2025 Annual Assessment payments. If you need assistance with your payments, please contact <u>Jenny@rotondawest.org</u>
- The Rotonda West Association Administration Office is pleased to offer notarization services for our members. So far this month, we've successfully assisted 28 individuals! Remember, this valuable service is free of charge, as we are committed to effectively supporting our members
- Continuing to pull unapproved signs or posts in the common areas, right of ways, and vacant lots, removing an additional **3** signs this week
- Collected approximately \$5,350 this week from members with past-due payments for deed restriction violations and past due assessments

## **Rotonda West Maintenance Staff**

- The Maintenance Staff has completed or is completing the following tasks:
- Mowing and picking up branches along the 3.5-mile walking paths, lakes, and the front entrance in Broadmoor Park

- Spot-treated weeds as necessary at all of the Memorial Parks and the Gazebo Island
- Mowed around and spot-treated the weeds around the 5 front entrance signs located from Cape Haze Drive to Boulevard East
- Removed metal and miscellaneous debris from Greenbelt common areas in the Oakland Hills section
- 20 hours of maintenance were conducted on the aquatic spray rig, Truxor, as well as the **15-foot** Rhino mowing deck. This maintenance involved the replacement of a radiator, **2** solenoids, a driveshaft, and several hydraulic hoses
- Mowing and treating the weeds around all of the apex bridges in the Oakland Hills,
   Pebble Beach, and White Marsh sections
- All American flags at the Memorial Parks have been replaced
- Mowed, trimmed, and edged the areas around the Community Center and the Administration building
- Cleaned up 5 unimproved vacant properties under Section 16 in the Pine Valley,
   White Marsh, and Oakland Hills sections. These properties are neglected and are

- Mowed the vacant lots in the Oakland Hills sections and finished mowing in the Greenbelts. Next week, we plan to continue mowing in the Pebble Beach and Pinehurst sections

- Broadmoor(finger lakes)
