- This week, we've made significant progress by updating our Section 16. tree removal list. There are currently 98 members remaining on our list who are working to bring their unimproved vacant lots into compliance by addressing issues related to Brazilian Pepper Trees and dead trees. - Processed and mailed out 7 delinquency letters for unpaid violations and assessments
- We have recently received 1 approval for a new construction plan from Cape Cave
 Corporation and have released 10 new construction deposits this week. This brings
 our total number of ongoing new construction projects to 187 homes. These homes
 are currently awaiting final occupancy certification under the New Construction
 Clean Site Program.
- Assisted members in setting up payment plans and successfully added 1 additional member this week
- Processed 2 Notice of Intent to Lien on properties in the Broadmoor sections for past due violation notices
- During the week, 98 members visited the Rotonda West Association Office for inquiries, applications, and to make their 2025 Annual Assessment payments. If you need assistance with your payments, please contact <u>Jenny@rotondawest.org</u>
- The Rotonda West Association Administration Office is pleased to offer notarization services for our members. So far this month, we've successfully assisted 4 individuals! We encourage you to visit the RWA office if you need a document notarized. Please ensure your documents are in English to help

- streamline the process. Remember, this valuable service is free of charge, as we are committed to effectively supporting our members
- Continuing to pull unapproved signs or posts in the common areas, right of ways, and vacant lots, removing an additional **11** signs this week
- Collected approximately \$2,481 this week from members with past-due payments for deed restriction violations and past due assessments

Rotonda West Maintenance Staff

- The Maintenance Staff has completed or is completing the following tasks:
- Mowing and picking up branches along the 3.5-mile walking paths, lakes, and the front entrance in Broadmoor Park
- Mowed and trimmed, with spot treatments applied as necessary, at all Memorial
 Parks
- Spot-treated weeds as needed at all Humpback and Apex bridges in the Broadmoor, Long Meadow, and White Marsh sections
- At the **Gazebo Island** in the Oakland Hills section, we have added **riprap** around the island to help prevent shoreline erosion. We removed the diseased and damaged trees, as well as broken concrete. We are currently grading and adding soil as needed, and in the coming weeks, we will be installing brick pavers and sod
- Mowed and trimmed the grass around the Administration and Community Center buildings, as well as the surrounding areas
- Completed 12 hours of maintenance this week on the Workman aquatic spray rig.
 The tasks included installing a new CV axle and brakes, adding bushings to the
 Truxor cutter, and replacing the crossfits on the axles on the 15-foot Rhino cutter
- Removed 1 invasive plant species along the canal bank in the Pinehurst sections

- Mowed the firebreaks along Parade Circle, from the Oakland Hills section to the Pine Valley section
- Mowed, trimmed, and treated the weeds at all of the 5 front entrance signs
- Mowed the intersections from Cape Haze Drive to East Blvd on Rotonda Circle and Boundary Blvd
- A new walking path has been established, linking L09 to L08. This pathway offers
 members the chance to enjoy picturesque views of a nearby lake, along with the
 diverse wildlife that inhabits the

- Cleaned up 3 unimproved vacant properties under Section 16 in the Long Meadow and White Marsh sections. These properties are neglected and are being charged for our services and fined https://rotondawest.org/wp-content/uploads/2021/09/P-P-1.6.pdf
- Mowed the vacant lots in the Pinehurst and Broadmoor sections, and will be mowing in the Broadmoor and Long Meadow sections next week
- Invasives, grasses, and submersed plants have been sprayed in the canals and areas listed below:

- Long Meadow(grasses)
- Pine Valley(grasses and water lettuce)
- The Truxor has been cutting and removing Vallisneria and grasses in the following sections.
- Pinehurst(Vallisneria)
- Broadmoor(Vallisneria)
- Pine Valley(Vallisneria)
- White Marsh(Vallisneria)
