The meeting was called to order by President Van Scyoc at 2:00 PM. The meeting was properly noticed, and a quorum was present.

Tina Kissane -110 Pebble Beach Rd. addressed the Board about Agenda item Deed Restrictions violation and referred Deed Restriction Amended Red Line document from the website; trash can violation. She stated that the Compliance office committee staff and Derrick requested the ADHOC committee to provide a clearer definition of what's visible. Visible as explained in section 18 page 16 of 30. "Garbage and Recycling/Outside Equipment: Except on the day immediately preceding the day of collection and the day of collection, garbage and recycling containers shall be kept either inside the garage, behind landscape shrubs or within a fenced area." Mr. Hedges explained that if it is visible from the front of the house from the street it is not in compliance.

MEMBERS INPUT (Non-Agenda Items)

Tina Kissane -110 Pebble Beach Rd. addressed the Board on the restriction or the proposal about members blocking their driveways. She inquired if this has been taken a step further as people who are placing rocks across their driveways or signs to block their lawn. While she can understand the turnaround, however, it could be a tripping hazard for walkers.

Dana Singer 478 Boundary Blvd. state that the canal banks have not been cut down and the response was that the equipment was broken. He also stated that the canal banks have not been sprayed along the water's edge and wants to know why it's not been taken care of. President Van Scyoc explained that the procedure has changed, and we are allowing for a buffer zone on the canal bank of approximately three to four feet to help filter out contaminates. Manager Hedges explained that allowing the canals to grow will help to get rid of the invasive species. He stated that he would be happy to meet with Mr. Singer and discuss his concerns.

Karen Gatling 586 Boundary Blvd. stated that she had a comment to add to Mr. Singer concerns. Grass is growing from the canal, measured out from the canal, where the property ends to the water extending into the Rotonda River up to ten feet. Ms. Gatling stated that she has lived here for 8 years now and has never seen the growth that extensive into the waterway. Concerned that the change in protocol of the maintenance of all the waterway in Rotonda West, something is changing as well as the appearance of the waterways and is not attractive. Mr. Hedges noted that he had received the photos of her area and explained that the grass is torpedo grass, which an invasive grass and we are taking steps to treat it accordingly.

Director Orchard congratulated the Election Committee and the Budget and Finance Committee for doing a great job. There was a fine for a sign and was questioned which then found out RWA sign guideline are old and they need to be updated, and she is willing to work with the staff and another board member who wants to get involved to investigate the information to update the guideline. President Van Scyoc that he would be willing to help.

President Van Scyoc thanked everybody for coming out and will see everyone at the next meeting.

COMMUNITY OUTREACH NATURE COMMITTEE PRESENTATION

On October 22nd, Charlotte County Lands Management specialist Robert Pasquali brought alligator facts to a Rotonda crowd of 64, with 15 more attending on Zoom. Our apex predator has a history of some 83.5 million years. Today, alligators can be found in parts of Texas and Oklahoma, east to North Carolina. In Florida, any fresh water lake, pond, or creek can house an alligator, and even brackish water is sometimes appealing to them.

Residents were encouraged to appreciate these reptiles from a safe distance, keep dogs leashed, and to always assume if there is water, alligators are present. It is illegal to feed, annoy or harass an alligator. Wildlife violations can be reported on: [myFWC.com/Wildlife Alert](https://myFWC.com/WildlifeAlert) or call 888-404-3922. Charlotte County holds a special permit allowing certain trained staff to capture and release alligators. To report a situation that may necessitate relocating an alligator, contact Jason Thompson, senior land management specialist at 941-613-3221 or Jason.Thompson@CharlotteCountyFL.gov.

- PAVING - Rotonda West PAVING began on **MONDAY July 21, 2025**. \$17 million
- PAVING started in the PINE VALLEY section and move counter-clockwise (White Marsh & Broadmoor, etc.); each section takes about 4-6 weeks.
- MSBU PAVING – BY RWA SECTIONS: AJAX PAVING – VENICE OFFICE
- PROJECTED PAVING SCHEDULE–Subject to weather & equipment & manpower delays/ issues
- PINEHURST SHOULD CONCLUDE BY LATE OCTOBER
- PEBBLE BEACH SHOULD START BY EARLY NOVEMBER
- OAKLAND HILLS SHOULD START BY EARLY DECEMBER
- ROTONDA CIRCLE & BOUNDARY – 1Q 2026 FULL DEP RECLAMATION DOWN 10 INCHES
- PUNCH LIST FOR ALL SECTIONS – SOD/MANHOLE COVERS, ETC
- Future issues of WEST WAYS shall include the projected start/finish for the remaining 2 RWA sections.
- Charlotte County Paving Project Manager is James Layport and his phone number is: 941-628-8084
- PERHAPS 30-DAY Paving schedule slips due to Weather & Equipment & Manpower issues.
- *ROTONDA BRIDGE #13 – ROTONDA BLVD SOUTH – UPDATE:
- *Some important movement – Army Corps of Engineers (ACOE) permit should be issued to Charlotte County by end of October, 2025. Public input period expired on October 24, 2025.
- *FEMA negotiations started, and a report was provided to FEMA including updated project costs of about \$1.8M (vs \$1.1M 3 years ago), a 64% cost increase. Government shutdown*!
- *Bid specification is ready to go out for bid, must wait for ACOE permit – perhaps November!
- *Bid close perhaps Jan 2026, County Commissioners award contract perhaps 1Q 2026*
- *Construction start perhaps 2Q 2026, completion expected 10-12 months later – **Dec. 2026???**
- Traffic lights at Gasparilla & Rotonda Boulevard East NOW scheduled for installation - 1Q 2026.
- Traffic lights at Gasparilla & Ingram/Ingraham are also to be installed in the 1Q 2026.
- Rotonda Bridges Rehabilitation Status: Bridge #106 – Long Meadow, completed ~10/06/2025; Bridge #060 – Oakland Hills, completed ~10/18/2025
- Remaining 4 bridges, (#110-#111-#112-#123) are scheduled for summer/fall of 2026.
- *US Government shutdown may affect completion of these items!!!

The next regular quarterly Rotonda West Streets & Drainage MSBU meeting shall be held on Thursday December 11, 2025, at 9:30am at the San Casa Road (DMV) Charlotte County facility.

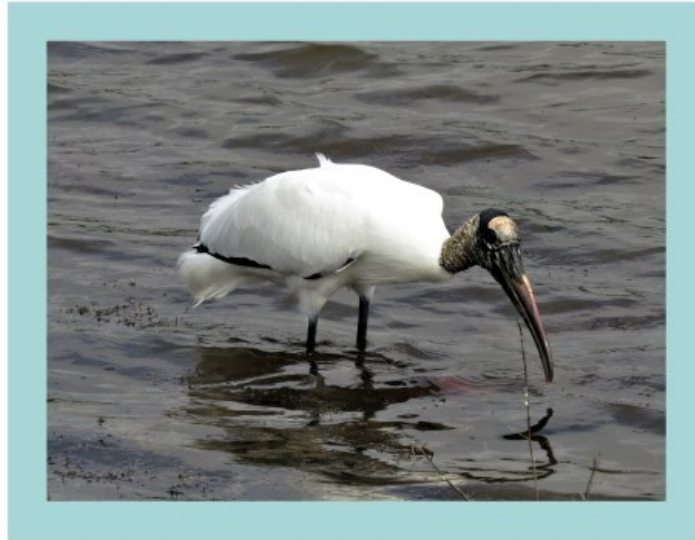

GARDEN TIP FOR NOVEMBER

Moving to Florida from nearly every other state means learning about an entire group of new plants for your yard. My Master Gardener training in Colorado was pretty useless here.

What do I wish I had learned earlier ?



A JATROPHA !

1. While non-native plants are beautiful, they often do not provide nectar for pollinators, bees, butterflies and food for birds. Bougainvillea, Starburst bush, bird of paradise – many of the “exotics”, non-native plants from Madagascar, China and Mexico are not appealing to our wildlife.
2. Landscape cloth or weed barrier does not prevent our weeds from taking root. Most weeds punch right through even the commercial variety. The barrier often restricts growth, sometimes girdling the trunks of trees and shrubs. It will prevent seeds from taking root when you want seedlings. Transplanting often requires the annoying extra step of removing the landscape cloth.
3. Once established, native Florida plants will grow without watering, relying on our rainfall. During extensive dry spells, some watering may be necessary. Native plants love our sandy soil and need no fertilizer. Time and money saved.
4. If a plant's requirements state “Full Sun”, many are happier in partial shade in our tropical environment.
5. Shade giving trees will cool your house and yard. Trees provide food and shelter for birds and other wildlife. The native live oak is host to hundreds of insects and caterpillars, making it a boon to wildlife. Planting 3 trees close to each other will allow their roots to interconnect, making them more wind resistant. The ideal distance between them will depend on the tree.
6. Some fast growing trees will break in storm winds. I lost a 6' tall royal poinciana during a tropical storm. Native trees such as Sweet Bay Magnolia, gumbo limbo, and sugarberry are hurricane survivors. See Peoplefortrees.com for native tree information.
7. Annuals such as pentas will last for 2 or 3 years if cut back after flowers fade.
8. I have discovered super foods such as katuk, moringa and chaya grow well here. Forget lettuce, spinach and tomatoes. But what fun to grow citrus, mangoes and pineapples!
9. Many mulch materials contain bald cypress, an important native tree that should not be killed to make mulch. I use only Florimulch which is made from melaleuca, an invasive tree introduced to dry up the Everglades. Dyed mulch may contain harmful chemicals and fades in our sunshine. Best to use a natural product.
10. The jatropha is an evergreen shrub, multi-stemmed, and covered with bright red flowers all year. It grows in full sun or part shade and can reach 15' tall. Jatropha takes pruning well and will bring monarch, swallowtail and Zebra long wing butterflies to your yard. This shrub is native to Cuba and the West Indies. All parts are toxic if ingested.

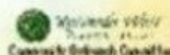

It is hard to believe that Thanksgiving is right around the corner; my favorite holiday by the way!. Soon to be followed by Christmas, Hanukkah, and Boxing Day (for all our Canadian friends), just to name a few. No matter what you will be celebrating, just remember there are opportunists out there looking for an opportunity to take advantage of us. Recently, there was a burglary where a side garage door was kicked in; power tools were stolen and house ransacked. The homeowner mentioned this burglary may not occurred if he had a deadbolt installed in addition to a locking door handle. In speaking with the Sheriffs department the addition of a deadbolt is more of a deterrent as the bolt goes into the casing further than a regular door lock. If you do not have a deadbolt on a side door it is recommended to get one installed.

Below are a few reminders to keep your valuables safe.

At Home:

- o Make sure all doors and windows have secondary locks (window pins, deadbolts, dowels, etc.) and use them!
- o Don't hide spare keys in mailboxes or planters, or under doormats.
- o Ensure that dark areas and entrances have outdoor lights that are turned on after dark or are activated by sensors.
- o Keep trees and shrubbery trimmed so they do not conceal doors and windows. Remember, overgrown foliage can provide a hiding place for criminals.
- o Place gifts where they can't be seen from the outside.
- o Be sure to mail cards, checks or gift certificates from the Post Office or at a blue U.S. Postal Service collection box.
- o Lock your vehicle and remove all the valuables. **Yes, even in your driveway.**

Strangers at your Door:

- o Use caution anytime there is a stranger at your door.
- o Be suspicious of unexpected sales calls or deliveries. Ask for identification.
- o Be aware of scams that criminals commit to take advantage of people's generosity during the holidays.
- o **Investigate charities before making donations.** Ask how the funds will be used.

Leaving for the Holidays:

- o Ask a trusted friend, neighbor or Neighborhood Watch member to watch your home.
- o Use timers for lights and radios while you're away.
- o Remember to make arrangements for mail and newspapers.

Talk with your neighbors, talk with your friends, and ask them to join you in preventing crime; it is just two hours a month. Remember without volunteers, we would not exist, and crime could increase.

GPS/Navigation for Mariners – US Coast Guard Approved Boating Safety Course

While the course will provide a general understanding of GPS navigation, it will not be specific to any particular brand or model of equipment.
