The ground was officially broken for the much-needed addition to the Administration Building at a ceremony on Thursday, November 13th.

A staffing increase was required to accommodate the needs of the growing Rotonda West community. This addition will help to alleviate the crowded working conditions that have been problematic for the staff.

A vote was held in 2024, and passed by a vote of 1300 to 309, to increase the staff office space by adding on to the current Administrative building. This will be accomplished with no increase to current HOA fees. Permits are pending and work should begin soon.

# RWA ANNUAL MEETING AND ELECTION RESULTS

The Rotonda West Association Annual Meeting will be held on Thursday, December 4th.

**The annual meeting is split, at 5 and 7 pm on Thursday, December 4 and the only opportunity for in-person voting is at 5 pm that day. Election results will be announced after the annual meeting resumes at 7 pm on December 4.**

This year, 2025, was the first year that electronic voting was offered in addition to mail-in voting, and in-person voting. Many residents signed up for this online voting opportunity through the RWA website page. Numbers show electronic voting has been successful.

As of December 1st, electronic voting is closed. In addition, mail-in ballots had to be received by the RWA's independent auditor, or at the RWA office by 4 pm on December 1st. Therefore, the only opportunity to still cast your ballot is in-person voting at the Annual Meeting between 5 and 5:15 pm on December 4th.

**PLEASE EXPLAIN “ROLLOVER OF EXCESS RWA HOA FUNDS” WHICH APPEARS ON THE BALLOT EACH YEAR**

Property owners are asked each year as a part of the RWA election process to VOTE either YES or NO to rollover excess funds.

**BELOW IS THE EXPLANATION FROM THE INDEPENDENT CPA AUDITOR:**

1. Common interest realty associations (primarily condominium and property owner / homeowner associations) are organized as not-for-profit corporations. For operating purposes, it is assumed the annual budgets for these associations will be prepared on a break-even basis, meaning expenditures will equal revenues. When an association has excess member revenue in any given year, there are three basic options available to the association regarding the treatment of the excess revenue:
  - A. Refund the excess revenue on a pro rata basis to the members of the association
  - B. Obtain member approval to “rollover” the excess revenue to the subsequent fiscal year
  - C. Retain the excess revenue and report this revenue as taxable income on the association’s Federal and/or State tax return
2. If the members do not approve the rollover of the excess revenue, an association has two options regarding the treatment of the excess revenue; either refund it to the members or report it as taxable income.

Please note: This is a general explanation. The rollover process is primarily based on the requirements of IRS Revenue Ruling 70-604

**MEMBERS INPUT** (Non-Agenda Items)

Sue Taylor – 12 Fairway Rd addressed the BOD stating her concern about rentals in Rotonda West. There is a house on the street -23 Fairway Rd. that is rented out for the next six weeks it has been loud parties with 10 cars on the front yard. She came to the office and asked what they can do, their response was that the homeowner is responsible, unless they have broken RWA rules there is nothing that can be done. President Van Scyoc response was nothing we could do we do not have control over members rentals. RWA can only fine the owner if RWA rules, restriction or guidelines have been violated. Ms. Taylor asked if a County Tourist Tax could be collected. She expressed she did not know that there were so many rental properties in RWA. President Van Scyoc responded that there is not a renter handbook or rule book, but they can fine the owner for the violation for parking in the yard, also could contact the police for the noise.

Gwen Grace – 50 Club House Rd. address the BOD about signs not election signs, signs for the RW women's club, we have several events coming up on October 26, for Scholarships. The other event is the Annual Holiday Bazaar on November 8, that we have every year, and the monies will go to local charities. I would like BOD



approval, the signs will be put up the week before the event, so they are not up long term. This will be the same time as putting up the signs for the RWA Open House event. RWA is doing what we can, they have put liens on these houses starting the foreclosure process. If you want to set up a meeting and can go through it with you. A new Attorney firm has been hired for these construction foreclosures.

- \*ROTONDA BRIDGE #13 – ROTONDA BLVD SOUTH – UPDATE:
- I wrote all of the Charlotte County Commissioners as well as the County Administrator and the County Director of Public Works and I got the following reply from Mr. John Elias, the Charlotte County Director of Public Works:
  - Sam, I will try to answer your questions this way:
  - **Sam Question: Is there any NEW news related to the Rotonda bridge, namely, did Charlotte County ever receive the ACOE permit after the public comment period ended on October 24, 2025?**
  - John Elias Answer: The public comment period has ended as you indicated. We expected to have the ACOE permit in hand already, but the government shut down has slightly delayed the process. We do expect it any day now.
  - **Sam Question: Have any further discussions been held with FEMA regarding the dollar amount to be provided to Charlotte County in light of the BCA court ruling in favor of Charlotte County in April of 2025?**
  - John Elias Answer: This has been a real challenge that has only been exacerbated by the shutdown. Unfortunately, no new news to report here.
  - **Sam Question: Has the bridge build bid specification been submitted to potential construction bidders?**



## CHARLOTTE COUNTY NEWS ITEMS CONTINUED...

- John Elias Answer: Sam, in light of not having the permit and the ambiguity surrounding the funding the bid specs and plans have not been advertised yet. It is our intent to discuss this with the Board for them to weigh in on moving forward. The risk is that we potentially lose any funding from FEMA if we proceed without that being completely agreed upon.
- **Sam Question: Also, has the RW S&D MSBU unanimous motion to MILL & GRIND Rotonda Circle been forwarded to the Charlotte County Commissioners for approval of the change order to the paving contractor?**
- John Elias Answer: The request of the RW S&D was forwarded to the BCC in the form of a point paper as I committed to do in our town hall. There has not been a lot of direction from the Board, so Administration has asked me to prepare an item to present to the BCC at an upcoming meeting. We are finalizing those numbers, which are significant (\$887,000), and in doing so, had to then do an analysis to confirm if there was enough funding in the MSBU to cover it. That has been confirmed so this will be added to a future agenda. It should be noted that some of the residents have already taken action to prepare their driveways for not milling and if we switch courses there will be frustration.
- If you have any other concerns or questions, please reach out. I
  - \*Construction start perhaps 1Q-2Q 2026, completion expected 10-12 months later **Dec. 2026?**
  - Traffic lights at Gasparilla & Rotonda Boulevard East NOW scheduled for installation - 1Q 2026.
  - Traffic lights at Gasparilla & Ingram/Ingraham are also to be installed in the 1Q 2026.
  - Rotonda Bridges Rehabilitation Status: Bridge #106 – Long Meadow, completed ~10/06/2025; Bridge #060 – Oakland Hills, completed ~10/18/2025
  - Remaining 4 bridges, (#110-#111-#112-#123) are scheduled for summer/fall of 2026.
  - \*US Government shutdown may affect completion of these items!!!

The next regular quarterly Rotonda West Streets & Drainage MSBU meeting shall be held on Thursday December 11, 2025, at 9:30am at the San Casa Road (DMV) Charlotte County facility.

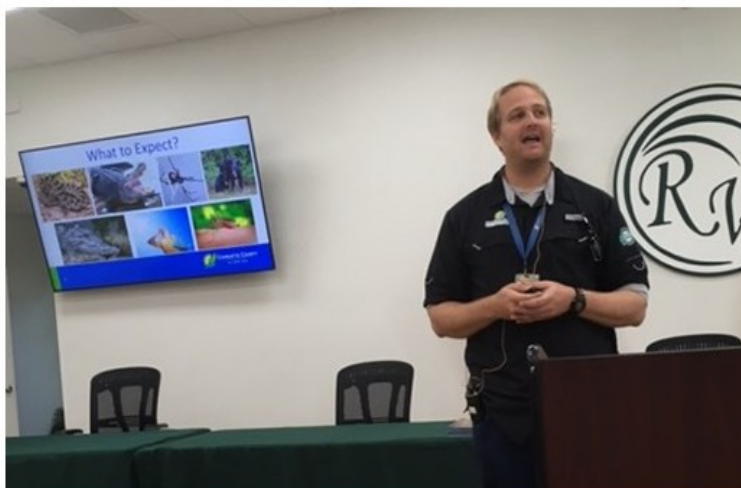

## Community Outreach Nature Committee Presentation

### How to Florida



November 12, 2025, Wednesday 2pm 646 Rotonda Circle  
David Smith, Charlotte County Natural Resources Lands Manager

David Smith covered a range of nature related topics about what to expect in Florida's unique ecosystem, whether out in one of the Charlotte County preserves, at Broadmoor Park or in your own backyard. From wildlife encounters to Florida Friendly Landscaping, what you do can make a difference. It's natural to fear what we don't know so we need to learn to identify wildlife and their habits and give them space. For instance, most snakes are harmless and provide natural pest control. Alligators also need space, so use common sense and be aware of your surroundings. People and animals should keep away from the waters edge. Equally important is to not feed wildlife. It is a danger to animals and people. But to bring birds, butterflies and pollinators into the landscape, we should practice Florida Friendly Landscaping, minimizing turf and planting native plants. The attendees had many questions and learned how to best enjoy our diverse and beautiful Florida nature.

## Community Outreach Nature Committee BROADMOOR NATURE WALK, SATURDAY 11/29/25

Over 30 people participated in the Broadmoor Nature Walk led by Dr. Bill Dunson of the Florida Nature Plant Society. He talked about the benefits of planting native and Florida Friendly plants for wildlife and how people can make their own yards wildlife friendly to attract pollinators and birds. He noted that Broadmoor has many native and Florida Friendly plants and would have more if we stopped mowing open areas. Dr. Dunson explained the several different habitats on the two hour walk. We saw 85 plants (30% non native), many birds and one small alligator sunning on the pond bank.

We toured the Broadmoor Butterfly and Native Plant Gardens, where Ann Weaver provided an overview of the plantings. The Cranberry hibiscus with red leaves in the Butterfly garden (bottom photo, on right) is currently very showy and is attracting both pollinators and people. These gardens are volunteer maintained and more volunteers are needed to keep them a centerpiece of the park.

## GARDEN TIP FOR DECEMBER

The Cranberry Hibiscus (*Hibiscus acetosella*) will bring a touch of fall color to your very green landscape. This is an annual, but will last a couple years in south Florida. Its bronze-purple leaves resemble a Japanese maple. Small deep burgundy flowers appear in late summer. It will grow to be a small tree in full sun with adequate moisture. It is a native to Africa.

After the flowers fade, the flower pod dries and can be collected for seeds. Plants will sprout next spring and transplant easily. There are two in the Broadmoor Park Butterfly Garden that are over 5 feet tall.

The Cranberry Hibiscus flowers and young leaves are edible and have a tart citrus flavor, a bit like cranberry. Add them to salads or use to brew tea. Leggy plants can be pruned to a leaf node. Pollinators love the flowers. Older plants should be replaced after 9-18 months.

### Rain is needed

Will it ever rain again? The soil is very dry. There is little chance of rain in the forecast. Help your landscape plants by bringing out the hose. I use the “t” shaped watering device to get to the deep roots. Even if you have irrigation, the water only hits the surface few inches. Some trees like the live oak (*Quercus virginiana*) have a tap root that finds its way to the water table. Many trees and palms do not, and an extensive drought can be fatal. An interim watering can make all the difference.

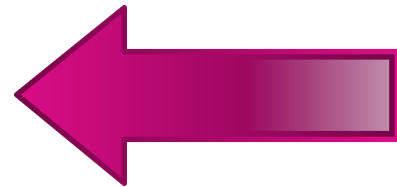

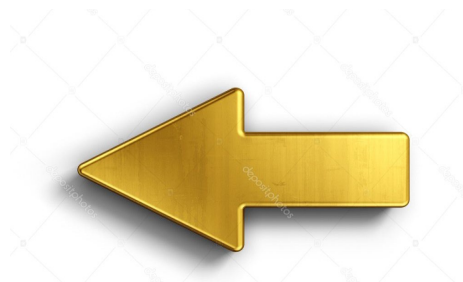

We hope everyone had a wonderful Thanksgiving and enjoyed time with family and friends—along with plenty of turkey, football, and apple pie. As we head into the holiday season, we also enter a time when “porch pirates” become more active in our neighborhoods. Recent reports indicate that nearly 30% of customers have experienced package theft.



Porch pirate prevention starts with making your deliveries harder to steal and easier to track. Consider using secure delivery options such as package lockers, pickup locations, or rerouting shipments to your workplace or a trusted neighbor who is home during the day. Installing a doorbell camera or using well-lit entryways can also deter thieves. When possible, schedule deliveries for times you’ll be home, and keep an eye on tracking updates so packages aren’t left unattended for long. A few simple steps can go a long way in protecting your holiday deliveries.

However, there were cases where packages were delivered to similarly named streets—such as Bunker Rd. instead of Bunker Ct. and some never made it back to their intended owner. Whenever possible, please make sure your address is written clearly and/or typed properly, including Courts, Roads, Drives, etc., to help carriers deliver accurately.

To help prevent this, UPS and FedEx offer options to reroute deliveries to your workplace or a designated pickup location. Many carriers also allow packages to be delivered to nearby stores or to a trusted neighbor who is usually home. The good news is that last year we had very few incidents.
